Facility Activity:

Discharge of secondary treated domestic wastewater from the Kodiak Wastewater Treatment Facility. Discharge shall occur at a daily maximum flow rate of 6.2 million gallons per day

Discharge Location:

The Kodiak Wastewater Treatment Facility discharges into Woody Island Channel at 57° 48.172" North latitude and 152° 20.919" West longitude.

Mixing Zones:

Mixing zones are proposed for fecal coliform bacteria, total ammonia as Nitrogen, copper, temperature, and whole effluent toxicity. The chronic mixing zone measures 77 meters long and 40 meters wide. The acute mixing zone, contained within the chronic mixing zone, measures 29 meters long and 39 meters wide.
