Subject: SIP Submittal of Amendments to the Fairbanks Moderate SIP Requirements

Dear Mr. Hladick:

This letter provides amendments to 18 AAC 50, Air Quality Control regulations, with an effective date of January 12, 2018. Specific provisions are being submitted for EPA approval with this cover letter, while other provisions are included for informational purposes only.

On December 13, 2017, the Lt. Governor signed and filed the following changes to the Alaska Department of Environmental Conservation's (DEC) regulations in 18 AAC 50:

- Repeal and readopt 18 AAC 50.030 to adopt revisions to the State Air Quality Control Plan in Volume II Section III.D.5: FNSB PM-2.5 Control Plan and its corresponding Appendix; and add language addressing nonattainment area permit requirements.
- Amend 18 AAC 50.075 to add new language on visible emissions standards and to remove language that is no longer applicable.
- Amend 18 AAC 50.077 to address requirements for wood-fired heating devices, heating device test methods, and address heating devices located in the FNSB nonattainment area.
- Add a new section, 18 AAC 50.079, to address requirements for coal-fired heating devices.
- Amend 18 AAC 50.990 to add definitions.

ADEC requests EPA approval of the following revisions and new regulations:

- 18 AAC 50.030(b) [new subsection];
- 18 AAC 50.075(f) [(f) is a new subsection];
- 18 AAC 50.077(a), (b), (c)(2), (d), and (g);
- 18 AAC 50.079 [new section];
- 18 AAC 50.990(71), (138)(C), (149), (150), and (151) [149-151 are new]; and Revisions to:
  - Volume II Section III: Areawide Pollutant Control Program: Section III.D.5.7 Fairbanks North Star Borough Fine Particulate Matter (PM<sub>2.5</sub>) Moderate Area Attainment Plan: Control Strategies; and



 Volume III: Appendix III.D.5.12: Appendix to Volume II. Analysis of Problems, Control Actions; Section III. Area-wide Pollutant Control Program; D. Particulate Matter; 5. Fairbanks North Star Borough PM2.5 Control Plan.

Additionally, ADEC requests EPA removal of the following repealed sections from the SIP:

- 18 AAC 50.075(e)(1) and
- 18 AAC 50.077(b)(2)(A)(i).

The following revisions were submitted under a November 26, 2018, cover letter for separate approval:

- 18 AAC 50.075(e); and
- Revisions to:
  - Volume II Section III: Areawide Pollutant Control Program: Section III.D.5.11 Fairbanks North Star Borough Fine Particulate Matter (PM<sub>2.5</sub>) Moderate Area Attainment Plan: Fairbanks Emergency Episode Plan; and
  - Pages 68-84 of Volume III: Appendix III.D.5.12: Appendix to Volume II. Analysis of Problems, Control Actions; Section III. Area-wide Pollutant Control Program; D. Particulate Matter; 5. Fairbanks North Star Borough PM2.5 Control Plan.

The remaining adopted revisions to 18 AAC 50 are being provided for informational purposes only, to show a complete record of the rulemaking package.
