Dear Mr. McLerran:

The Alaska Department of Environmental Conservation (ADEC) hereby submits a revision to our State Implementation Plan (SIP) and requests EPA approval of the submission in accordance with 40 C.F.R. 51. The revisions to 18 AAC 50 had an effective date of January 4, 2013, and include the following changes:

- adopt new standards, maximum allowable increases, significant impact levels, and emission thresholds for specific air pollutants and adopt associated clarifying changes in 18 AAC 50.010, 18 AAC 50.020, 18 AAC 50.035, 18 AAC 50.040, 18 AAC 50.215, 18 AAC 50.502.
- update adoption by reference dates of federal rules adopted in 18 AAC 50.040.
- repeal language in 18 AAC 50.040 that is now duplicated by other regulations.
- adopt revised language and clarifications to existing regulations in 18 AAC 50.020, 18 AAC 50.215, 18 AAC 50.306, and 18 AAC 50.540 to provide consistency with earlier amendments.
- add new language clarifying permit applicability to 18 AAC 50.502.
- adopt revised language to clarify modeling requirements in 18 AAC 50.540.
- expand the fast track permitting option to include minor permits classified for fine particulates (PM-2.5) in 18 AAC 50.542.

ADEC requests EPA approval of the applicable parts of the submission found in 18 AAC 50.010(5); 18 AAC 50.020(a)-(b), (e), and new subsection (g); 18 AAC 50.035(b); 18 AAC 50.040(h) - (i); 18 AAC 50.215(b) and (d); 18 AAC 50.306(b); 18 AAC 50.502(c) and new subsection (i); 18 AAC 50.540(c)-(d) and new subsection (j); and 18 AAC 50.542(c).

ADEC previously submitted for EPA approval the portions of the regulations package relating to the Infrastructure SIP requirements found in 18 AAC 50.030.
