Dear Mr. McLerran:

The Alaska Department of Environmental Conservation (ADEC) hereby submits a revision to our State Implementation Plan (SIP) and requests its approval in accordance with 40 C.F.R. 51. The revisions to 18 AAC 50 have an effective date of September 14, 2012, and include the following changes:

- update adoption by reference dates of federal rules adopted in 18 AAC 50.035 and 18 AAC 50.040;
- adopt a federal rule part and new subparts in 18 AAC 50.040;
- repeal or delete obsolete language in 18 AAC 50.035, 18 AAC 50.040, 18 AAC 50.990, and 18 AAC 50.990 Editor's note;
- add language to adopt and require Title V standard application forms in 18 AAC 50.035 and 18 AAC 50.326;
- clarify modeling requirements in 18 AAC 50.215;
- clarify requirements for owner requested limits in 18 AAC 50.225; and
- adopt clarifications to existing regulations to correct wording, to correct cross-references, and resolve internal regulation conflicts in 18 AAC 50.220, 18 AAC 50.302, 18 AAC 50.326, 18 AAC 50.345, 18 AAC 50.400, and 18 AAC 50.540.

ADEC requests EPA approval of the applicable parts of the submission found in 18 AAC 50.035(a)-(b); 18 AAC 50.040(f), (h), and (i); 18 AAC 50.215(c)-(e); 18 AAC 50.220(c)(3); 18 AAC 50.302; 18 AAC 50.345; 18 AAC 50.540; and 18 AAC 50.990.
