tons of Particulate Matter, 6.2 tons of Nitrogen Oxides, 0.04 tons of Sulfur Dioxide, 5.3 tons of Carbon Monoxide, and 245 tons of Volatile Organic Compounds. The total emissions of

regulated air pollutants is 257 tons per year.
