

## NOTICE OF PUBLIC COMMENT PERIOD ON PROPOSED CHANGES TO ALASKA DEPARTMENT OF ENVIRONMENTAL CONSERVATION REGULATIONS

The Department of Environmental Conservation (DEC), proposes to adopt regulation changes in Title 18, Chapter 50 of the Alaska Administrative Code dealing with Air Quality Control, including the following:

- adopt new standards, maximum allowable increases, significant impact levels, and emission thresholds for specific air pollutants and adopt associated clarifying changes in 18 AAC 50.010, 18 AAC 50.020, 18 AAC 50.035, 18 AAC 50.040, 18 AAC 50.215, 18 AAC 50.502.
- adopt the following revisions to the State Air Quality Control Plan in 18 AAC 50.030 to comply with federal Clean Air Act requirements:
  - Volume II: Analysis of Problems, Control Action:
    - Section II: Air Quality Control Program
    - Section III.H.1: Interstate Transport of Lead Pollution; and
  - Volume III: (Appendices to Volume II)
    - 18 AAC 50 proposed regulation amendment;
    - Clean Air Act Section 110 Infrastructure Certification Documentation;
    - AAC Title 2- Administration; Chapter 50- Alaska Public Offices Commission: Conflict of Interest, Campaign Disclosure, Legislative Financial Disclosure, and Regulations of Lobbying; Article 1 – Public Official Financial Disclosure (2 AAC 50.010- 2 AAC 50.200); and
    - AAC Title 9 – Law; Chapter 52 – Executive Branch Code of Ethics (9 AAC 52.010 – 9 AAC 52.990).
- update adoption by reference dates of federal rules adopted in 18 AAC 50.040.
- repeal language in 18 AAC 50.040 that is now duplicated by other regulations.
- adopt revised language and clarifications to existing regulations in 18 AAC 50.020, 18 AAC 50.215, 18 AAC 50.306, and 18 AAC 50.540 to provide consistency with earlier amendments.
- add new language clarifying permit applicability to 18 AAC 50.502.
- adopt revised language to clarify modeling requirements in 18 AAC 50.540.
- expand the fast track permitting option to include minor permits classified for fine particulates (PM-2.5) in 18 AAC 50.542.

Comments must be received by **5:00 p.m., on April 10, 2012**. Comments received after this date will not be considered in final action on these rules.

The Department has tentatively scheduled a public hearing for these proposed regulations on **April 5, 2012** from 2:00 p.m. to 3:30 p.m. at the Department of Environmental Conservation Building, 619 E. Ship Creek, Ste. 249, Conference Room B, Anchorage, AK 99501. The public

hearing will be held only if a request to hold a public hearing is received by DEC by 5:00 p.m. on **April 3, 2012**. You may request a public hearing by calling DEC/s Division of Air Quality at 907-465-5105 between 9:00 a.m. and 5:00 p.m., Monday through Friday or by e-mailing a request to [dec.aq.airdocket@alaska.gov](mailto:dec.aq.airdocket@alaska.gov). If no request for a public hearing is received, the public hearing will be cancelled. DEC will announce the cancellation of the public hearing by publishing a public notice, by 5:00 p.m. on **April 4, 2012**, on this website: [http://dec.alaska.gov/commish/public\\_notices.htm](http://dec.alaska.gov/commish/public_notices.htm) Oral or written comments may be submitted at the hearing if a public hearing is conducted. If the public hearing occurs, there will be a call-in number if you are not able to attend the meeting in person. The call-in number will be 1-800-315-6338, and the Meet Me Code will be 8123#. If held, the hearing may be extended if necessary to accommodate those present before 3:00 p.m. who did not have an opportunity to comment.

After the public comment period ends on **April 10, 2012**, DEC will either adopt these or other provisions dealing with the same subject, without further notice, or decide to take no action on them. The language of the final regulations may be different from that of the proposed regulations. **YOU SHOULD COMMENT DURING THE TIME ALLOWED IF YOUR INTERESTS COULD BE AFFECTED.** Written comments received are public records and are subject to public inspection.
