



# 2018 Geoduck Dive Vessel Application

## APPLICATION INSTRUCTIONS

This annual application must be submitted for a dive vessel to be used for shellfish harvesting. The fee for this permit is \$162.00 per year.

1. Type or print all responses in ink.
2. Indicate the type of marine sanitation device: holding tank, commercial porta-potty or other sanitation device. All devices must be contained or valved to prevent sewage discharge while in the harvest area. Discharges of sewage, bilge water or domestic waste water are allowed at sea if three (3) miles or more away from shore and if outside the approved harvest area.
3. Provide two drawings of your vessel; a top down (floor plan) deck view and a side view. Identify the vessel and hold finish material construction, and indicate the location of all plumbing on the drawings (sewer, water and hydraulic lines and hand sink with hot and cold water source). Drawings must be of a reasonable scale (1" = 4 feet or larger) showing overall dimensions of the vessel.
4. Identify location or placement of storage areas for geoducks and containers used to transport geoducks.
5. Animals (pets) are not allowed on harvest vessels.
