## RE: Wrangell Junkyard treated soil packaging, transportation, and disposal 2018.

### Ms. Schlichting,

*NRC Alaska* is pleased to provide the following Project Status update for the Wrangell Junkyard Solid Waste transportation and disposal Project. Our goal is to provide a status update on a weekly basis, with photos and notes as appropriate so that all interested parties may remain apprised on progress in the field on a regular basis. We are currently performing work as detailed in the soil transport and disposal plan and the Storm Water Pollution Prevention Plan (SWPPP) for the project as detailed under Alaska Pollutant Discharge Elimination System (APDES) permit # AKR10FQ51. This Project Status Update covers project activities as performed between **October 22, 2018 and October 28, 2018**.

#### **Project Activities:**

Activities during the 2018 field season will focus on the loading of Flexible Intermediate Bulk Containers (FIBC) and 20cy open top containers. Transfer of FIBC's/containers to the Silver Bay Logging Mill Site (SBLMS) barge staging area for loading and transport to a disposal facility in Oregon. Awaiting final barge loading. Implementation of initial SWPPP measures and road maintenance. Post project sampling by Nortech.

#### Project activities accomplished:

- All remaining treated/packaged soil from the junkyard site has been loaded onto the final barge and shipped off Wrangell for disposal.
- Site restoration activities have been completed.
- Crew re-mobilized to the site 10/24/18.
- Final inspection with ADEC completed on 10/18/18.
- Final barge loading completed 10/26/18.
- Project complete and crew de-mobilized 10/28/18.
