TIME/DATE OF DISTRIBUTION: 5:00 p.m. on June 4, 2019

POTENTIAL RESPONSIBLE PARTY (PRP): Big State Logistics, Inc. (BSL)

INCIDENT LOCATION: The incident occurred at MP 36 Dalton Highway, approximately 40 miles North of Livengood and 20 miles South of the Dalton Hwy Yukon River crossing: N65.74237°, W-149.34827°.

TIME/DATE OF SPILL: The incident occurred at approximately 3:00 PM on June 3, 2019.

HOW/WHEN SPILL WAS DISCOVERED AND REPORTED: The department was notified by the Alaska State Troopers on June 3, 2019 at 7:00pm.

TYPE/AMOUNT OF PRODUCT SPILLED: The spilled product is Ultra-Low Sulfur Diesel (ULSD). The tractor trailer was transporting approximately 9,500 gallons of ULSD. The amount of spilled ULSD is currently estimated to be approximately 2,000 gallons.

CAUSE OF SPILL: Vehicle accident. The truck departed the Dalton Highway and then rolled as the passenger side wheels of the tractor and trailer came off the shoulder of the road.

SOURCE CONTROL: The remaining fuel in the tractor trailer was lightered and recovered from the incident scene overnight between June 3 and 4, 2019.

RESPONSE ACTION: Big State Logistics arrived onsite within a few hours of the incident and provided personnel and resources for the initial response. Some product recovery was conducted using absorbent material, but most of the ULSD migrated in to surface and subsurface soils. Currently, BSL and ADEC personnel are on-site to conduct delineation activities.

RESOURCES AT RISK OR AFFECTED: Only surface and subsurface soils within the Alaska Department of Transportation & Public Facilities right-of-way are known to be affected at this time.

FUTURE PLANS AND RECOMMENDATIONS: ADEC will continue to monitor the response actions and review plans being developed to clean up contaminated material at the site.

WEATHER: Current: 81°F, partly cloudy, North winds at 5-10MPH. Tonight: Partly to mostly cloudy; low 48°F; Winds light and variable. Tomorrow: Mostly sunny; high 69°F; North-East winds at 5-10MPH.

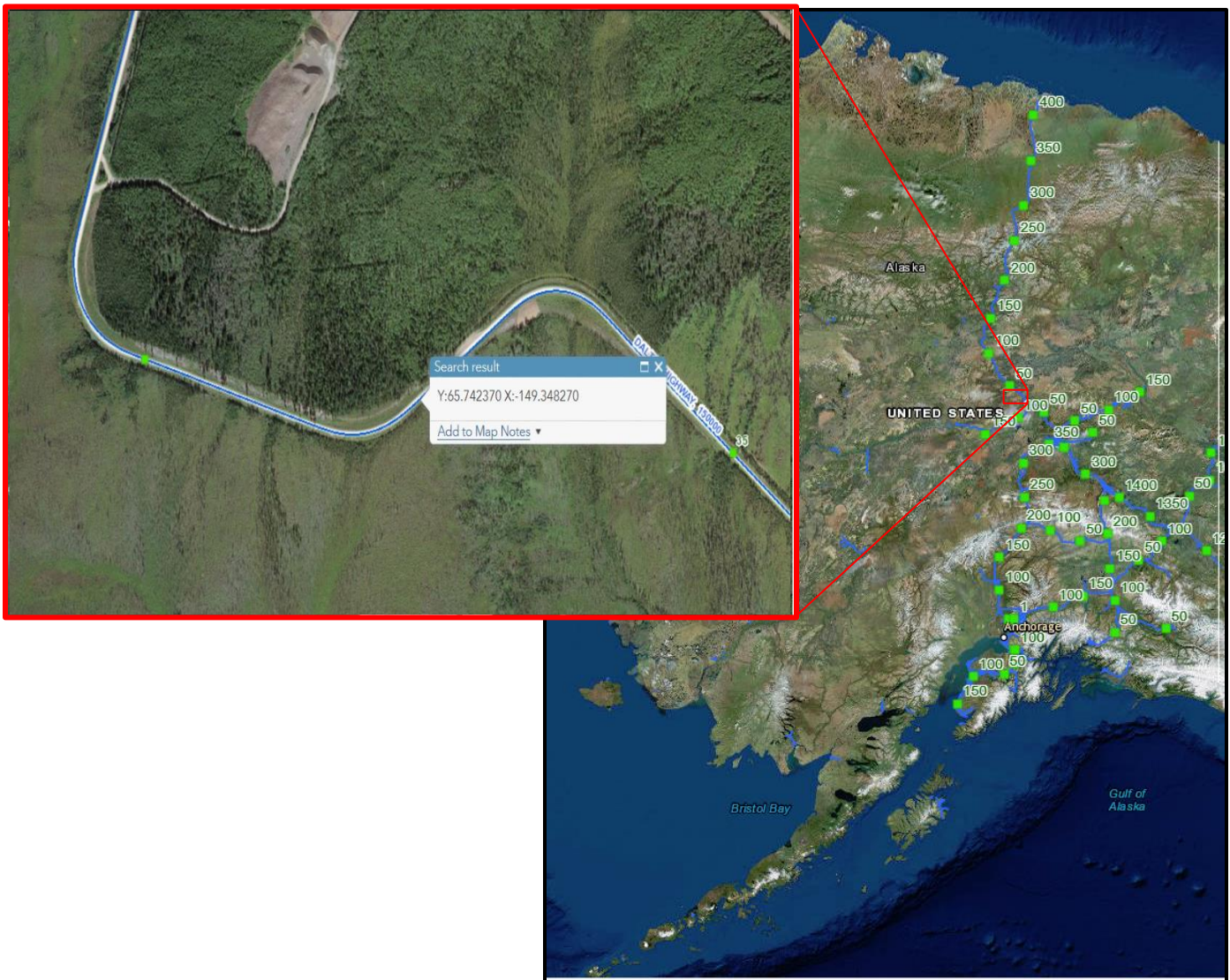


Figure 1: The incident took place at MP 36 Dalton Highway, 40 miles North of Livengood, Alaska.
