## 2005 Hazardous Waste Offloading and Generated in Alaska

#### **OFFLOADING**

As part of the plan required under AS 46.03.475(e)(2), Commercial Passenger Vessels operating in the State of Alaska are required to submit a hazardous waste and hazardous substance offloading plan to the Department of Environmental Conservation (DEC) for each year of operation within the state. This plan must describe the vessels policies and procedures for offloading hazardous waste within Alaska.

Most commercial passenger vessels **do not** offload hazardous waste in Alaska and do not have to submit a plan. However all vessels have to fulfill requirements required under AS 46.03.475(d) by providing a copy of hazardous waste manifests submitted to Federal or Provincial governments to show disposal of hazardous wastes GENERATED while operating in state waters.

**AS 46.03.826** defines hazardous substance as; (1) an element or compound which, when it enters into the atmosphere or in or upon the water or surface or subsurface land of the state, presents an imminent and substantial danger to the public health or welfare, including but not limited to fish, animals, vegetation, or any part of the natural habitat in which they are found; (2) oil; or (3) a substance defined as a hazardous substance under 42 U.S.C. 9601(14)<sup>1</sup>;

# MANIFESTS FOR HAZARDOUS WASTE GENERATED IN ALASKA

## Large Ships

The following table (Table 1) provides the actual volumes of hazardous waste GENERATED by commercial passenger vessel while operating in Alaska and offloaded in Canada, Washington and California during the 2005 season.

#### Small Ships

Small ships do not have dry-cleaning or photo processing on board. Small ships do not produce enough hazardous waste to be required by law to manifest these wastes to a Federal or Provincial government. Typically, the only hazardous waste produced by the small vessels is used oil. However, some small ships have voluntarily reported other hazardous wastes that were offloaded during the 2005 season in Alaska, Canada, and Washington. The quantity and description of hazardous waste offloaded by the small vessels while operating in Alaska is summarized in Table 2.

## **Large Ships**

## **Princess Cruise Lines**

All ships submitted information pertaining to each major waste stream in summary table. The Sapphire, Island, Regal and the Diamond Princess submitted info on incinerator ash and/or blackwater. All of the waste streams were off loaded out of state.

The Island Princess has a volume of dry cleaning waste that is considerably lower than any of the other Princess ships, and this is due to the shipboard practices of reusing the old liquid waste instead of adding new fluids.

## **Holland America Lines**

All ships submitted information pertaining to each major waste stream with the exception of the Ryndam and Statendam who did not report dry cleaning waste. In an effort to reduce certain waste streams Holland America has replaced the dry cleaning systems on board the Ryndam and Statendam with new "wet cleaning systems" which uses soap and water instead of the hazardous chemicals that dry cleaning systems use. The reduced oil waste volume on board the Zaandam can also be explained by Holland America's efforts to reduce certain waste streams. Currently the Zaandam has installed new equipment that reduces oily bilge water and additional equipment that allows for oil sludge to be reused. All waste streams were offloaded out of state in Canada.

#### **Royal Caribbean Cruise Lines**

All ships submitted information pertaining to each major waste stream. All offloads occurred out of state in Canada and California.

#### **Celebrity**

All ships submitted information for each major waste stream. All offloads occurred out of state in Canada.

#### Norwegian

All ships submitted information pertaining to each major waste stream in summary table. All offloads occurred out of state.

### **Carnival Spirit**

The Carnival Spirit submitted information for each major waste stream except dry cleaning, which is a service not offered aboard ship. All offloads occurred out of state.

#### **Seven Seas Mariner**

The Seven Seas Mariner submitted information for each major waste stream except for paint waste. All offloads occurred out of state

## **Crystal Harmony**

The Crystal Harmony submitted information pertaining to each major waste stream in the summary table. All offloads occurred out of state except for 15m<sup>3</sup> of incinerator ash which was offloaded in Canada.

# **Small Ships**

### **Glacier Bay**

The Wilderness Discoverer and Adventurer estimated an offload of 500 gal (1893 liters) of used lube oil; this number is a combined estimate for both ships. Information was obtained from the vessel's operators submitted plans at the beginning of the season.

#### **Cruise West**

Cruise West reported the actual volumes of used oil for all ships offloaded while operating in Alaska. The Spirit of Oceanus did not offload any used oil in the Alaska.

#### Alaska Marine Highway

Alaska Marine Highway (AMHS) reported a combined total for all state ferries for the offload of waste oil in Alaska. Additionally, AMHS reported other hazardous waste substances that were offloaded in Alaska and Washington during the 2005 season.

## **Lindblad Expeditions**

Lindblad reported that Sea Lion and Sea Bird did offload a small amount of miscellaneous hazardous waste in Alaska during the 2005 season.

## **New World Ship Management**

New World Ship Management reported that the Yorktown Clipper offloaded oily sludge in Alaska during the 2005 season. It was also reported that the Clipper Odyssey did not offload any hazardous waste in Alaska during the 2005 season.

#### **American West Steamboat Company**

American West Steamboat Company reported that the Empress of the North did not offload hazardous waste in Alaska during the 2005 season.
