Subject: SIP Submittal of Regional Haze Revisions

Dear Mr. Sixkiller:

This letter provides amendments to Alaska's *State Air Quality Control Plan* or State Implementation Plan (SIP) for Regional Haze and associated regulations. The revised regulations have an effective date of August 21, 2022. Specific provisions are submitted for EPA approval, while other provisions are included for informational purposes only, to show a complete record of the rulemaking.

On July 22, 2022, the Lt. Governor signed and filed the following changes to the Alaska Department of Environmental Conservation's (DEC) regulations in 18 AAC 50:

- Amend 18 AAC 50.025(a) to add a Regional Haze Visibility Protection Area, as defined in Volume II Section III.K.13.H of the *State Air Quality Control Plan*.
- Amend 18 AAC 50.030(a) to adopt revisions to the State Air Quality Control Plan by
  - adopting Volume II, Section III. Area Wide Pollutant Control Program, Subsection K.13 Regional Haze 2<sup>nd</sup> Implementation Period and the Appendices to Sections III.K.13.F, III.K.13.G, III.K.13.H, III.K.13.I, and III.K.13.K; and
    - amending Volume III Appendix to Volume II, Section II.A to incorporate the proposed regulations after public review and comment. This appendix within the State Air Quality Control Plan contains the state's air quality regulations.
- Adding new section 18 AAC 50.265 to establish requirements for sources in the Regional Haze Visibility Protection Area.

DEC is submitting the relevant parts of the Regional Haze amendments to EPA for approval today. Changes and additions to the following revised sections of the *State Air Quality Control Plan/SIP* and 18 AAC 50 are being submitted for approval:

- 18 AAC 50.025(a)
- 18 AAC 50.265

 SIP Volume II, Section III. Area Wide Pollutant Control Program, Subsection K.13 Regional Haze 2<sup>nd</sup> Implementation Period and the Appendices to Sections III.K.13.F, III.K.13.G, III.K.13.H, III.K.13.I, and III.K.13.K

We will submit the documents listed in the enclosures via the EPA's SPeCS system. If requested, we can provide one paper copy and one electronic version of the documents to Kristin Hall of your staff (note that the electronic version would be an exact duplicate of the paper copy).
