**Kraft Macaroni and Cheese recalled for possible small metal pieces**

(JUNEAU, AK) – Kraft Foods Group has issued a recall for selected code and manufacturing dates because they may contain small pieces of metal.

Recalled products include “Kraft Macaroni & Cheese Boxed Dinner Original Flavor” sold in the following four configurations:

1. 7.25 oz box
2. 3-pack box of those 7.25 oz. boxes
3. 4-pack shrink-wrap of those 7.25 oz. boxes
4. 5-pack shrink-wrap of those 7.25 oz. boxes

Alaska DEC has confirmed these products were available in Alaska. To date, Kraft has received eight consumer contacts and no reports of injuries, illnesses, or reactions have been reported in Alaska.
