## NOTICE OF PUBLIC COMMENT PERIOD ON PROPOSED CHANGES TO ALASKA DEPARTMENT OF ENVIRONMENTAL CONSERVATION REGULATIONS

The Department of Environmental Conservation (DEC), proposes to adopt regulation changes in Title 18, Chapter 50 of the Alaska Administrative Code dealing with Air Quality Control, including the following:

- update adoption by reference dates of federal rules adopted in 18 AAC 50.035 and 18 AAC 50.040.
- adopt a federal rule part and new subparts in 18 AAC 50.040.
- repeal or delete obsolete language in 18 AAC 50.035, 18 AAC 50.040, 18 AAC 50.990, and 18 AAC 50.990 Editor's note.
- add language to adopt and require Title V standard application forms in 18 AAC 50.035 and 18 AAC 50.326.
- clarify modeling requirements in 18 AAC 50.215.
- clarify requirements for owner requested limits in 18 AAC 50.225.
- adopt clarifications to existing regulations to correct wording, to correct crossreferences, and resolve internal regulation conflicts in 18 AAC 50.220, 18 AAC 50.302, 18 AAC 50.326, 18 AAC 50.345, 18 AAC 50.400, and 18 AAC 50.540.
