SITUATION REPORT

INCIDENT NAME: F/V Destiny Grounding

SITREP #: 2 and Final

SPILL NUMBER: 03259918201

TIME/DATE OF SPILL: The U.S. Coast Guard reported the vessel grounding to ADEC at 10:00 a.m. on July 1, 2003.

TIME/DATE OF SITUATION REPORT: 1:00 p.m. on July 3, 2003

TIME/DATE OF THE NEXT REPORT: This is the final report.

TYPE/AMOUNT OF PRODUCT SPILLED: The operator estimated the spill volume to be less than 5 gallons of engine oil from the engine space.

LOCATION: On a sandy beach Northeast of Port Moller, at 56 12.296N 160 23.904W.

CAUSE OF SPILL: Wave action in the surf zone has removed the vessel cabin, filling the vessel with water and sand.

POTENTIAL RESPONSIBLE PARTY (PRP): Mr. Lazary Kuzman

RESPONSE ACTION: PRP was able to remove an estimated 200 gallons of diesel fuel and 100 gallons of oily water from the vessel. Salvage personnel were unable to gain access to the 2 vessel batteries and an estimated 11 gallons of hydraulic fluid. The PRP will go back to the site today to remove additional vessel debris from the site. The PRP does not feel that he will be able to remove the vessel from the beach because the vessel is sanded in, below the high tide line.

The F/V Destiny was a 40 foot fiberglass gill net vessel.

SOURCE CONTROL: Almost all of the fuel was removed from the vessel. The PRP will continue to return to the vessel to gather debris and look for opportunities to remove any additional oil from the vessel.

RESOURCES AFFECTED: No impacts to wildlife or other resources have been reported.

FUTURE PLANS AND RECOMMENDATIONS: ADEC with the Coast Guard will continue to monitor the debris removal and any other oil removal from the vessel.

WEATHER: Clear, Temperature 64°F, Wind Southwest at 15-20 knots

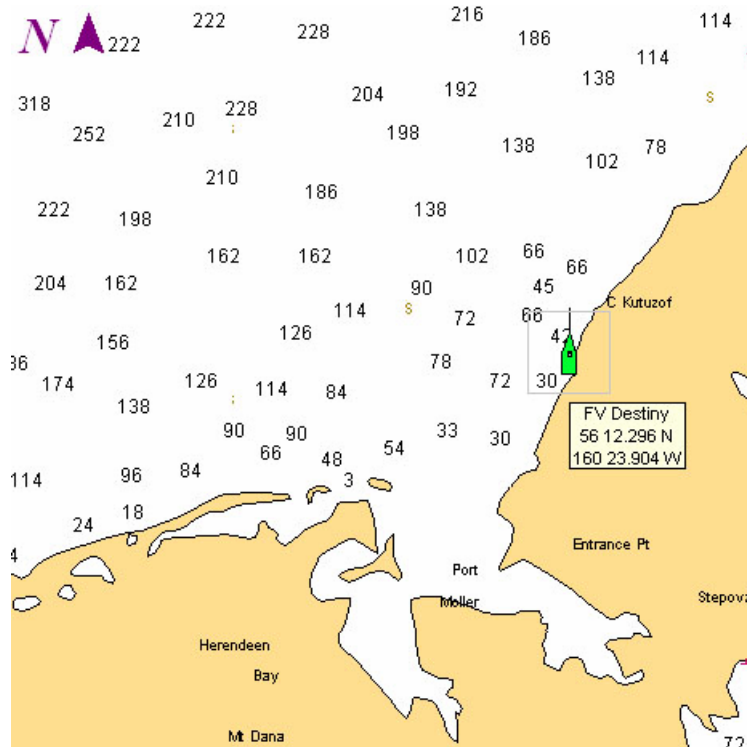
