**SITUATION REPORT**

**INCIDENT NAME:** F/V Donna Ann

**SITREP #:** 2 and final

**SPILL NUMBER:** 03239923202

**TIME/DATE OF SPILL:** U.S. Coast Guard reported to ADEC that the vessel grounded at 2:40 a.m., August 20, 2003.

**TIME/DATE OF SITUATION REPORT:** 4:00 p.m., August 21, 2003

**TIME/DATE OF THE NEXT REPORT:** This is the final report

**TYPE/AMOUNT OF PRODUCT SPILLED:** The vessel owner reported 1000 gallons of diesel was on board the vessel at the time of the grounding. Further gauging of fuel tanks on August 22<sup>nd</sup> found no fuel in the tanks.

**LOCATION:** Tanglefoot Bay, Karluk, on Kodiak Island

**CAUSE OF SPILL:** F/V Donna Ann, a 58' wooden hulled vessel, drifted aground on a gravel and sand beach after dragging anchor in Tanglewood Bay at 2:40 a.m. on August 20.

**POTENTIAL RESPONSIBLE PARTY (PRP):** Owner of F/V Donna Ann, David W. Johnson

**RESPONSE ACTION:** ADEC and U.S. Coast Guard staff performed an overflight of the grounding site this afternoon. No sheening was observed during that overflight. ADEC and Coast Guard spill responders landed at the site, met with the vessel owner, and performed a beach assessment. They did not find any fuel contamination on the beach or high tide lines. It is assumed the vessels diesel fuel was dispersed during yesterday's storm.

The vessel owner is currently trying to collect debris that had been torn from the vessel during yesterday's storm.

**SOURCE CONTROL:** The vessel owner will make an attempt to remove a small amount of hydraulic fluid remaining on the vessel.

**RESOURCES AFFECTED:** No shoreline contamination observed during shoreline assessment at low water today. No impacted wildlife was reported or observed during shoreline assessment.

**FUTURE PLANS AND RECOMMENDATIONS:** The vessel owner will continue to collect debris from the vessel. The vessel owner is also looking for assistance in removing the vessel from the beach. ADEC and U.S. Coast Guard representatives activated for the response will be returning to their home base. ADEC shall coordinate with ADNR to preclude unresolved abandoned vessel concerns.

**WEATHER:** Temperature 59 degrees F., Wind: SW 5 mph, Seas: 1-2 foot.
