SITUATION REPORT

INCIDENT NAME: F/V Raven

SITREP #: 1

SPILL NUMBER: 03259928801

TIME/DATE OF SPILL: The actual time of the spill is unknown. The vessel reported to the U.S. Coast Guard that the vessel was taking on water and listing approximately 30 degrees. The vessel was also reported to be about to sink on October 15, 2003 at 2:30 p.m.

TIME/DATE OF SITUATION REPORT: 11:30 a.m., October 16, 2003

TIME/DATE OF NEXT REPORT: 11:00 a.m., October 20, 2003

TYPE/AMOUNT OF PRODUCT SPILLED: Spill volume is unknown at this time; the vessel operator reported to the U. S. Coast Guard that there was 11,000 gallons of diesel fuel on board the vessel.

LOCATION: At the time of the personnel rescue, the vessel was located approximately 50 miles north of Cold Bay in position 55° 55' N 162° 46' W.

CAUSE OF SPILL: The cause of incident is unknown and under investigation by the Coast Guard.

POTENTIAL RESPONSIBLE PARTY (PRP): Mr. Lyle Yeck, Vessel Operator

RESPONSE ACTION: The U. S. Coast Guard responded and rescued F/V Raven personnel from the listing vessel.

The vessel operator has contracted Magone Marine Inc. to re-float and salvage the 85 ft. steel F/V Raven. The contractor departed Dutch Harbor in the early morning of October 16 and is expected to arrive at the vessel's location early on the morning of October 17. The U. S. Coast Guard Cutter Morgenthau is standing by in the vicinity of the F/V Raven. The F/V Raven is reported as currently listing 50°.

SOURCE CONTROL: Magone Marine has been contracted to plug all fuel vents in addition to stabilizing and re-floating the vessel.

RESOURCES AFFECTED: Marine waters. No reports of oiled wildlife have been received.

FUTURE PLANS AND RECOMMENDATIONS: U.S. Coast Guard and ADEC will continue to monitor the situation.

WEATHER: Overcast, snow flurries, winds northeast 30 knots, seas 10 ft.

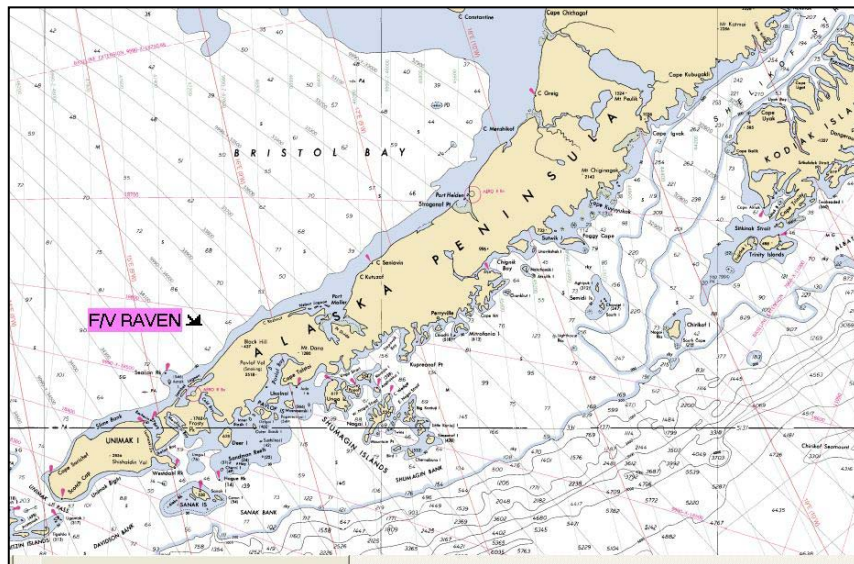
