SITUATION REPORT

INCIDENT NAME: Big State Logistics, MP 75 Richardson

SITREP #: 1 and Final

SPILL NUMBER: 04229901301

LEDGER CODE: Not Requested

TIME/DATE OF SPILL: The time of the incident was approximately 8:15 p.m. on January 13, 2004. The Alaska State Troopers notified ADEC of the imminent threat of a spill from a rolled tractor-trailer pup tank at 8:30 p.m. on January 13, 2004.

TIME/DATE OF SITUATION REPORT: 1:30 p.m., January 14, 2004

TIME/DATE OF THE NEXT REPORT: This is the final report

TYPE/AMOUNT OF PRODUCT SPILLED: There was no spill. The potential spill from the tractor trailer pup tank was 5,300 gallons of number 1 diesel.

LOCATION: Mile Post 75 on the Richardson Highway, 75 miles North of Valdez.

CAUSE OF SPILL: The tractor-trailer pup tank got off the shoulder of the road on the east side of the highway and rolled up side down. Deep snow in the ditch cushioned the tanker and prevented it from tearing open.

POTENTIAL RESPONSIBLE PARTY (PRP): Big State Logistics

RESPONSE ACTION: Big State Logistics responded with an empty tanker truck and pumps to lighter the overturned tank.

ADEC response staff from Valdez also mobilized to the site to assess and assist in the response needs. The responder confirmed that the tank received minimal damage and that no fuel had escaped containment. Damage to the tank was limited to a little wrinkle in one corner

SOURCE CONTROL: Response crews finished emptying the tank at 3:00 a.m. on January 14, 2004

RESOURCES AFFECTED: No spill, no natural resources were affected.

FUTURE PLANS AND RECOMMENDATIONS: ADEC staff will monitor the wreck removal.

WEATHER: Winds from the West 25 mph, blowing snow, Temperature 10 ° F
