TIME/DATE OF THE NEXT REPORT: This is the final report.

TYPE/AMOUNT OF PRODUCT SPILLED: Five (5) to 50 gallons of diesel fuel

LOCATION: Just inside Jack Bay, Prince William Sound

CAUSE OF SPILL: Fuel tank was over-filled.

POTENTIAL RESPONSIBLE PARTY (PRP): Crowley Marine Services – Tug Pathfinder

RESPONSE ACTION: SERVS was conducting on-water fishing vessel training at the time so several different on-water response tactics were used to clean up the sheen in the water.

SOURCE CONTROL: The fuel source was shut off and the tug was boomed.

RESOURCES AFFECTED: Waters of Jack Bay in Prince William Sound. Morning over flight on 29 April 2004 indicated a minor gravel beach impact at Levshakoff Creek.

FUTURE PLANS AND RECOMMENDATIONS: A Shoreline Assessment Team (SCAT) is going out at low tide to assess beach impact in Jack Bay.

WEATHER: Overcast, fog, and light rain. Very light breezes

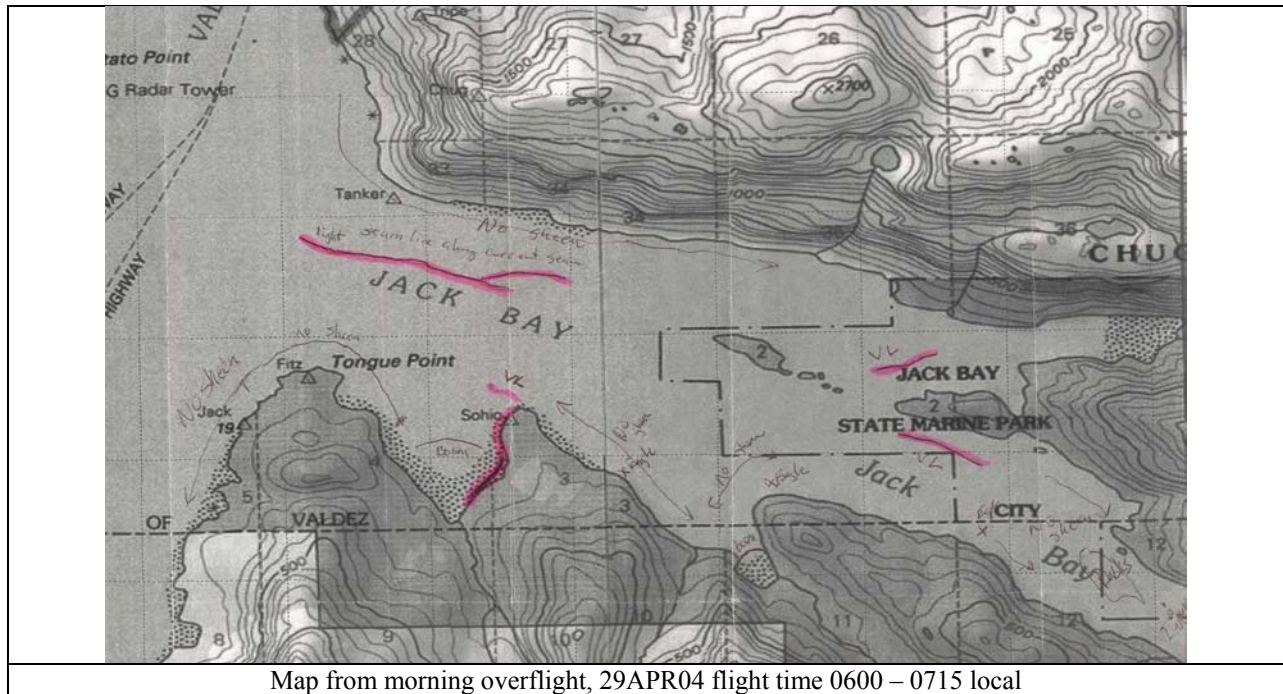




Photo of beach with light sheen along water line
