**SITUATION REPORT**

**INCIDENT NAME:** M/V Hayden Bay Grounding

**SITREP #:** 1

**SPILL NUMBER:** 04119916801

**LEDGER CODE:** None Requested

**TIME/DATE OF SPILL:** 5:20 A.M., June 16, 2004. The incident was reported to ADEC by the US Coast Guard at 8:45 A.M.

**TIME/DATE OF SITUATION REPORT:** 3:30 P.M., June 16, 2004

**TIME/DATE OF THE NEXT REPORT:** 10:00 A.M., June 17, 2004

**TYPE/AMOUNT OF PRODUCT:** Diesel fuel, unknown amount. The Responsible Party reported that the vessel has a 500 gallon capacity fuel tank. No oil has been reported to have spilled.

**LOCATION:** Kah Shakes Cove, Misty Fjords National Monument, (Lat 55.029 N, 131 001 W). Approximately 35 miles southeast of Ketchikan.

**CAUSE OF INCIDENT:** The M/V Hayden Bay, a 40 ft. fiberglass passenger vessel, grounded and sank after hitting an unmarked rock.

**POTENTIAL RESPONSIBLE PARTY (PRP):** Kurt Redd, Portland, Oregon

**RESPONSE ACTION:**

Alaska Commercial Diving from Ketchikan has been hired by the Responsible Party to respond. Estimated time of arrival on scene for the salvor is 4:00 P.M., June 16, 2004. The Responsible Party has directed the salvor to boom the vessel, plug the fuel vents, pump out the fuel and then attempt to raise the vessel. The U.S. Coast Guard reported that Taquan Air has flown over the site where the vessel has sunk and that no oil sheen was observed.

**SOURCE CONTROL:** All fuel and oils remain on board at this time.

**RESOURCES AFFECTED:** The vessel is aground and sunk at high tide in Kah Shakes Cove. There are no reports of injured wildlife or marine waters being affected.

**FUTURE PLANS AND RECOMMENDATIONS:**

Continue coordination with the Responsible Party and the Coast Guard on any salvage operations and other concerns as they occur.

Coordinate with Department of Natural Resources, Department of Fish and Game, and other stakeholders to address any concerns.

The Coast Guard will continue to investigate the cause of the grounding of the vessel.

**WEATHER:** Clear, approx 70 degrees, winds light and variable
