SITUATION REPORT

INCIDENT NAME: M/V Hayden Bay Grounding

TIME/DATE OF SPILL: 5:20 A.M., June 16, 2004. The incident was reported to ADEC by the US Coast Guard at 8:00 A.M., June 16, 2004

TIME/DATE OF SITUATION REPORT: 11:30 A.M., June 17, 2004

TIME/DATE OF THE NEXT REPORT: 12:00 P.M., June 18, 2004

TYPE/AMOUNT OF PRODUCT: Diesel fuel, unknown amount. The Responsible Party reported that the vessel has a 500 gallon capacity fuel tank. The Coast Guard has reported that a diesel fuel odor and minor sheen was detected upon arrival on June 16th, however that quickly dissipated. The salvor reported to the Coast Guard on June 17th that no sheens have been detected.

LOCATION: Kah Shakes Cove, Misty Fjords National Monument, (Lat 55.029 N, 131 001 W). Approximately 35 miles southeast of Ketchikan.

CAUSE OF INCIDENT: The M/V Hayden Bay, a 40 ft. fiberglass passenger vessel, grounded and sank after hitting an unmarked rock. There were two (2) people on board that were safely evacuated in a life raft and later picked up by the Coast Guard and taken to Ketchikan.

POTENTIAL RESPONSIBLE PARTY (PRP): Kurt Redd, Portland, Oregon

RESPONSE ACTION:

On June 17, 2004, Alaska Commercial Divers from Ketchikan reported to the USCG that they are in the process of installing flotation bags on the vessel. They have reported the vessel is submerged in approximately 71 feet of water and that they were unable to observe any damage to the vessel's hull in its current position. Once the vessel is lifted, a complete survey will be conducted to the keel and areas of the hull that are currently obstructed. The USCG stated that a 10:00 A.M. status report is expected from the salver on current conditions on scene. Oil containment boom has been deployed around the vessel.

SOURCE CONTROL: The fuel vents have been plugged. All fuel and oils remain on board at this time.

RESOURCES AFFECTED: The vessel ran aground and sank in Kah Shakes Cove. There are no reports of injured wildlife.

FUTURE PLANS AND RECOMMENDATIONS:

Continue coordination with the Responsible Party and the Coast Guard on any salvage operations and other concerns as they occur. In the event of an oil release, ADEC will coordinate with Department of Natural Resources, Department of Fish and Game, and other stakeholders to address their concerns. The Coast Guard will continue to investigate the cause of the grounding of the vessel.

WEATHER: Clear, 60-65 degrees, winds North at 6 kts., Seas 2-4 feet
