SITUATION REPORT

INCIDENT NAME: Dutch Harbor Mud Slide Event
(Formerly "Magone Marine Dutch Harbor Waste Oil")

SITREP#: 2

SPILL NUMBER: 06259904401 (for Magone Marine Services Inc.)

LEDGER CODE: 14204960

TIME/DATE OF SPILL: The incident occurred during an extreme weather event on February 13, 2006, which resulted in mudslides, roof collapses, and mobile containers being pushed into the bay. The incident was reported to ADEC on February 14, 2006 at 3:10 PM, by the Division of Emergency Service.

TIME/DATE OF SITUATION REPORT: 2:30 PM, February 17, 2006.

TIME/DATE OF THE NEXT REPORT: As the situation warrants.

TYPE/AMOUNT OF PRODUCT SPILLED: Magone Marine Inc. staff has located 8 punctured waste oil barrels as a result of the mudslide. ADEC staff estimates a potential release of 400 gallons of waste oil and water. Most of the drums contained oily bilge water residue.

LOCATION: City of Unalaska and Dutch Harbor, Alaska.

CAUSE OF SPILL: Mudslide into waste oil storage facility and other commercial buildings.

POTENTIAL RESPONSIBLE PARTY (PRP): Magone Marine Services Inc., and/or Ounalashka Corporation.

RESPONSE ACTION: ADEC responders are on site monitoring cleanup operations. The responders have met with facility personnel and completed inspections of Magone Marine Services Inc, Offshore Systems Incorporated (OSI), North Pacific Fuel, and American Seafood's Warehouse.

Magone Marine Services personnel continue to locate damaged drums and transfer the contents of those drums into a storage tank. They have recovered their 20 foot container, which was being used as a paint locker, from the Bay. There was only one small spill of paint to land which was cleaned up immediately. Magone Marine plans to conduct a diving operation when visibility improves to locate two motor vehicles which may have been pushed into the Bay.

The Offshore Marine Services facility was inspected and one of their warehouses did receive considerable damage when the roof collapsed. There was no damage to their Freon tank or above ground fuel tanks. There was a spill of 261 gallons of fish oil which is being cleaned up with the other debris.

The North Pacific Fuel facility was inspected and two areas within the secondary containment area were found detached from the liner seam. One opening was approximately 6 inches in length and the second opening was approximately 24 inches in length. Repairs to the secondary containment are in process. There was no damage to any tanks or piping. Repairs will need to be made to the security fence surrounding the tank farm.

American Seafood's warehouse received considerable damage from the mudslide. There are several damaged drums of lube oil mixed with the debris from the building that will be recovered when safety conditions improve to allow access to the partially collapsed building. The ADEC responders provided a liner from the State's spill response cache in Dutch Harbor for use in a temporary drum storage area as the site is being cleaned up.

Overall, all the spills associated with this incident are being managed using sorbent pads. In the event a larger spill is discovered, cleanup plans will be developed and monitored by ADEC staff.

SOURCE CONTROL: Facility personnel are working to access and secure drums of oil and other hazardous materials displaced by the mudslide.

RESOURCES AFFECTED: Soil and surface water at Dutch Harbor/Unalaska. There have been no reports of any impacts to wildlife.

FUTURE PLANS AND RECOMMENDATIONS: Two ADEC spill response staff will stay in Dutch Harbor through the afternoon February 18, 2006 to continue to assist the community in any way they can. As cleanup plans are developed, ADEC staff will provide oversight and program coordination.

WEATHER: Overcast. Highs in the upper 30°F, Southwest winds 15 MPH with gusts up to 22 MPH.
