<u>TYPE/AMOUNT OF PRODUCT SPILLED</u>: This is an informational sitrep on the current situation at the Pelican Seafoods facility in Pelican, AK. There has been no release reported to the Department, but the situation presents a potential anhydrous ammonia release.

LOCATION: Pelican Seafoods, Inc. - Pelican, AK.

CAUSE OF SPILL: Beginning on August 16, 2009, heavy rains in Pelican caused severe flooding of the area. At approximately 2:30 AM on August 20, 2009, a 30-foot section of the water flume supplying water to both the City of Pelican and the Pelican hydroelectric plant collapsed, damaging the main water supply line and leaving the town without a water supply. Water from the flume also provides cooling water to the Pelican Seafoods fish processing facility's refrigeration system. The hydroelectric plant was undergoing maintenance at the time of the incident and the town was already using the backup diesel generator.

POTENTIAL RESPONSIBLE PARTY (PRP): Ed Bahrt, Ed Bahrt & Associates, LLC, and Kake Tribal Corporation.

RESPONSE ACTION: On September 8, the saddle needed to plumb the new pump that was received on August 30 into Pelican's temporary water system arrived and was immediately installed. The installation of the pump and saddle now allows maximum water flow and pressure to the community of Pelican and the fish processing plant, permitting normal operations to resume.

A 300-foot section of the city's original sixty-year old water distribution piping has had reoccurring breaks during the water shortage and the breaks are continuing to occur. The City of Pelican and a contractor working on the Pelican water and power construction project has been assisting the City with the repairs to the line. Pelican has ordered piping and parts to completely replace the original section of water distribution piping. This project will be undertaken as soon as the parts arrive in Pelican.

The Pelican Utility District (PUD), owned by Kake Tribal Corporation, notified ADEC that its cost of generating power has increased substantially as the PUD is running on diesel power. The hydroelectric plant normally used to generate electricity has been removed as part of an Alaska Energy Authority construction project in Pelican. The PUD can no longer afford to continue providing power to the seafood plant. Loss of electric power could result in an uncontrolled release of anhydrous ammonia and impact the safety and welfare of the residents of Pelican.

ADEC has issued letters to both potential responsible parties requesting the submittal of plans outlining how they intend to mitigate or control a release of anhydrous ammonia should one occur due to failure of the temporary water line from the reservoir, or a disruption in the electric service to the seafood plant.

SOURCE CONTROL: There is no reportable discharge at this time.

RESOURCES AFFECTED: There has been no major release of anhydrous ammonia at this time and no resources have been affected.

<u>FUTURE PLANS AND RECOMMENDATIONS</u>: Both potential responsible parties are to submit to ADEC a plan of action on how they will mitigate or control a release of anhydrous ammonia should one occur.

The City of Pelican and a contractor will continue to perform necessary repairs to the Pelican water distribution piping and will replace the original sections when parts arrive.

The construction project to upgrade the electric and water systems will continue until completed next year.

WEATHER: Rain, heavy at times. Southeast winds 35 mph with gust up to 50mph.
