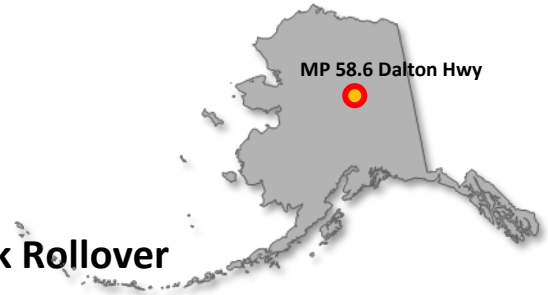

## **Tena Trucking Dalton Highway MP 58.6 Truck Rollover**

**SITREP #:** 2 and Final

**SPILL #:** 15309908301

**TIME/DATE OF DISTRIBUTION:** 9:00 a.m. September 7, 2017

**POTENTIAL RESPONSIBLE PARTY (PRP):** Tena Trucking, LLC (Tena)

**INCIDENT LOCATION:** Dalton Highway milepost 58.6, approximately three miles north of the Dalton Highway Yukon River crossing.

**TIME/DATE OF SPILL:** The incident occurred at approximately 7:30 a.m. on March 24, 2015, and was reported to ADEC at 11:30 a.m. on the same day.

**TYPE/AMOUNT OF PRODUCT SPILLED:** The Tena tractor-trailer was transporting ultra-low sulfur diesel (ULSD) fuel. The tanker had 10,002 gallons of ultra-low sulfur diesel (ULSD) fuel and released 870 gallons onto the public land managed by the Bureau of Land Management (BLM).

**CAUSE OF SPILL:** A northbound Tena tractor-trailer hauling fuel from Fairbanks to Deadhorse exited the west side of the roadway and rolled into the ditch. The front compartment of the trailer was punctured during the incident. The tractor, which separated from the trailer, remained upright and continued approximately 100 yards off the roadway. The driver is not believed to have been injured during the incident.

**SOURCE CONTROL:** The truck was righted and removed from the site.

**RESPONSE ACTION:** Tena responded to the incident by hiring Michael L. Foster and Associates (MLFA) to manage the cleanup activities. MLFA developed a 10 X 10' grid overlaying the release. The excavation limits extended to approximately 0.3 acres with the bottom elevation about three feet below the forest floor. The response contractor excavated, loaded, and hauled 158 semi-side or end dump trucks of contaminated soil from the incident site to Organic Incineration Technologies (OIT) for thermal treatment. Between April 7 – May 3, 2015, OIT received 2,695.19 tons of contaminated soil from the incident site.

Field screening and analytical confirmation samples collected in accordance with the approved project work plans were taken from the sidewalls and bottom of the excavation site. Surface water and interstitial ice melting in the excavation site was moving through the site during breakup conditions. Analytical samples were also collected from the pooled water. Based on the information provided by MLFA, the Department determined that the tactics performed and the analytical data obtained support an acceptable numeric cleanup level.

MLFA prepared and submitted the site restoration plan to BLM, which involves phased site management for the next several successive years. Approximately 2,280 cubic yards of backfill soil was imported to the excavation site and seeded with BLM approved seed stock.

**RESOURCES AT RISK OR AFFECTED:** The spill impacted the BLM managed area.

**FUTURE PLANS AND RECOMMENDATIONS:** The Department has determined that the lowest practicable level of contamination has been achieved and no further cleanup actions are required at this time. Therefore, the Department has closed this case.

**WEATHER:** At time of the release: A mix of clouds and sun; high 22°F; winds northeast at 5 to 10 mph. Tomorrow: Partly cloudy; high 26°F; winds north-northeast at 5 to 10 mph.
