KOTZEBUE POWER PLANT**

The Alaska Department of Environmental Conservation (ADEC) has made a preliminary decision to issue Air Quality Control Minor Permit AQ0196MSS09 for the Kotzebue Power Plant. ADEC intends to incorporate the minor permit into the Title V operating permit as an administrative revision after EPA's 45-day review, per 18 AAC 50.542(e).

**Applicant:** Kotzebue Electric Association, PO Box 44, Kotzebue, AK 99752

**Location:** 66° 53' 38.08" N, 162° 35' 45.54" W

**Activity:** The minor permit is classified under 18 AAC 50.508(6) for revising or rescinding the terms and conditions of a Title I permit. Only conditions being revised in response to the application and as described in the technical analysis report (TAR) are open to public comment.

**Emissions:** There are no changes in stationary source emissions due to the requested revisions to permit conditions.

**Preliminary Review:** Based on review of the application, ADEC drafted a preliminary permit decision for the project under AS 46.14 and 18 AAC 50.

**Opportunity for Public Participation:** Any interested person may present written statements relevant to the preliminary decision within 30 days after the first publication date. ADEC will consider all comments received and make any changes ADEC finds beneficial or necessary to assure compliance with 18 AAC 50 or state law. ADEC will issue a final decision to issue or deny the permit after the close of the public comment period. Any person may request a public hearing and that hearing will be held if ADEC finds that good cause exists.
