The Alaska Department of Environmental Conservation (ADEC) has made a preliminary decision to approve Hilcorp North Slope, LLC's application for Air Quality Control Minor Permit AQ0272MSS03 for the Lisburne Production Center (LPC).

Applicant: Hilcorp North Slope, LLC

Location: Latitude 70° 17' 6.3" North; Longitude 148° 25' 54.3" West

Activity: Hilcorp North Slope, LLC applied for a minor permit under 18 AAC 50.508(5) to establish owner requested limits (ORLs) to avoid Prevention of Significant Deterioration (PSD) permit classification under 18 AAC 50.306.

Emissions: There is no change on the stationary source's potential emissions due to this permit action. The total annual potential emissions of regulated air pollutants, other than greenhouse gases, are 3,391.87 TPY.

ADEC Preliminary Review: Based on review of the application, ADEC drafted a preliminary permit decision for this project under AS 46.14 and 18 AAC 50.

ADEC will consider all comments received and make any changes ADEC finds beneficial or necessary to assure compliance with 18 AAC 50 or state law. ADEC will issue a final decision to issue or deny the permit after the close of the public comment period.
