Swanson River Field

The Alaska Department of Environmental Conservation (ADEC) has made a preliminary decision to approve Hilcorp Alaska, LLC's application for Air Quality Control Operating Permit AQ0059TVP04 for the Swanson River Field, under Alaska Statutes 46.14 and regulation 18 AAC 50.

Applicant: Hilcorp Alaska, LLC, 3800 Centerpoint Drive, Suite 1400, Anchorage, AK 99503

Location: 60° 43' 37" North; 150° 52' 23" West

Application: As required by 18 AAC 50, Hilcorp Alaska, LLC applied for a renewal operating permit for Swanson River Field. ADEC received the application on January 6, 2025. This public notice is for the draft operating permit only.

Activity: The Swanson River Field is an oil and gas production field. Equipment at the Swanson River Field includes gas-fired engines and heaters, gasoline-fired engines, flares, and a refuse incinerator. The source also includes drill rig emission units.

Emissions: The potential annual emissions of regulated air pollutants at the stationary source will not exceed: 2,645.10 tons of Nitrogen Oxides, 443.17 tons of Carbon Monoxide, 50.45 tons of Particulate Matter, 51.04 tons of Sulfur Dioxide, 271.79 tons of Volatile Organic Compounds, and 19.91 tons of Hazardous Air Pollutants (HAP). The potential annual emissions for Greenhouse Gases are estimated at 192,289 tons of carbon dioxide equivalent emissions. The total annual potential emissions of regulated air pollutants, other than greenhouse gases, are 3,461.55 tons.

ADEC Preliminary Review: Based on the review of the application, ADEC drafted a preliminary permit decision for the Swanson River Field under AS 46.14 and 18 AAC 50.

ADEC will issue a final decision to issue or deny the permit after the close of the public comment period.
