Pursuant to 18 AAC 75.375 Raymond Vroble, as the owner and operator of the subject property, hereby provides public notice that the property located at: Mile 15 McCarthy Road, Alaska, 99566, and more particularly described as follows:

Tract 6 Coats Subdivision within surveyed Section 22; Township 4 S; Range 7 E; Copper River Meridian, Alaska. Filed under Plat number 87-8, in the records of the Chitina Recording District, Third Judicial District, State of Alaska.

has been subject to a discharge or release and subsequent cleanup of oil or other hazardous substances, regulated under 18 AAC 75, Article 3, as amended October 9, 2008. This release and cleanup are documented in the Alaska Department of Environmental Conservation (ADEC) contaminated sites database at http://www.dec.state.ak.us/spar/csp/db_search.htm under Hazard ID number 23279.

Attached is a site survey that shows the property boundaries, the extent of the remaining contamination is unknown and the land owner and/or operator are required under 18 AAC 75.300 to evaluate the environmental status of the contamination in accordance with applicable laws and regulations; because further site characterizations and cleanup may be necessary under 18 AAC 75.325-.390.

Pursuant to 18 AAC 75.325(i)(1) and (2), DEC approval is required prior to moving soil or groundwater that is, or has been, subject to the cleanup rules found at 18 AAC 75.325-.370. At this site, in the future, if soil is removed from the site or groundwater is brought to the surface (for example to dewater in support of construction) it must be characterized and managed following regulations applicable at that time.

This NEC remains in effect until a written determination from ADEC is recorded that states that soil and/or groundwater at the site has been shown to meet the most stringent soil cleanup levels in method two of 18 AAC 75.340 and/or groundwater meets the cleanup levels in Table C in 18 AAC 75.345 and that off-site transportation of soil and/or groundwater is not a concern.
