Hi Dara,

Here is the draft closure Record of Decision and draft report comments.

Could you look over and see if this is OK with CIRI. Feel free to turn on track changes and edit if you have suggested revisions. Typically we try to get concurrence from future landowners whenever contamination is left in place. This is not strictly required under our regulations but it is good practice. In this case the contaminants do not pose a risk to human health. Standard conditions for closed sites are still in place and are detailed in the letter. This letter will be attached to the database entry of the closed site so it will be public.

If you concur with the decision please send an email or letter stating that and I'll include it in the file.

I'll wait until I hear back from you to finalize these comments and the ROD.

If you don't have a copy of the draft report the comments won't make much sense, so let me know if you need a copy or I'll ask FAA to get one to you.
