Dear Mr. Cochran:

The Contaminated Sites Program is conducting an audit of contaminated sites closed with conditions (Institutional Controls) to verify that closure stipulations such as periodic monitoring and reporting are being performed by the responsible party of record as required under state law (18 AAC 75.375).

In May 2014, R&M Consultants, Inc. (R&M) performed groundwater monitoring and well decommissioning at the ASD Student Transportation Facility. Groundwater monitoring results indicated that ADEC cleanup levels were exceeded for diesel range organics (DRO) and residual range organics (RRO) in MW-04, and for benzene in MW-01. It was recommended by R&M that groundwater sampling continue for at least one additional sampling event, to occur in the spring of 2015. The Alaska Department of Environmental Conservation (DEC) concurred with R&M's recommendation (via email correspondence on July 30, 2014). However, ADEC's records indicate we have not received a report documenting the 2015 groundwater monitoring. Please find enclosed, the 2014 Groundwater Monitoring Report letter issued by R&M and the email correspondence demonstrating ADEC's request for an additional groundwater monitoring event to occur spring 2015.

Requested Documentation

In order to ensure that conditions at the site are protective of human health, welfare and the environment, DEC requests that you provide the following:

- Results from the spring 2015 groundwater sampling event. If monitoring has not been performed, please schedule a current event **as soon as possible**.

In addition to the groundwater monitoring requirement, please be advised that the following Standard Institutional Controls continue to apply:

- Any proposal to transport soil or groundwater off-site requires ADEC approval in accordance with 18 AAC 75.325. A "site" [as defined by 18 AAC 75.990 (115)] means an area that is contaminated, including areas contaminated by the migration of hazardous substances from a source area, regardless of property ownership.
- Movement or use of contaminated material in a manner that results in a violation of 18 AAC 70 water quality standards is prohibited.

DEC is concerned that the site conditions may not be protective. Failure to maintain these requirements may result in re-opening of the site by the Contaminated Sites Program, in which case, further remediation could be mandatory.
