The purpose of this letter is to inform you that the Alaska Department of Environmental Conservation (ADEC) Storage Tank Program will begin cost recovery actions at documented leaking underground storage tank (LUST) sites, effective December 1, 1997.

This notice is sent to you because information in our records indicates that you are the owner of the following site and responsible for cleanup costs as they occur. If you believe that you have received this letter in error, or that there are responsible parties other than yourself, please contact ADEC immediately at (907) 465-5301.

The State is authorized, under 42 U.S.C. 699 1 b(h) to recover, from a responsible party, funds expended from the Leaking Underground Storage Tank Trust Fund for corrective action or enforcement action with respect to the release of petroleum from an underground storage tank. The State is also authorized by AS 46.08.070 to recover money expended by the Department to contain or cleanup the release of oil or a hazardous substance.


Costs eligible for recovery include Department staff salaries, travel, equipment, supplies, contracts and services, and general program management. Typical cost expenditures for staff time can

include, but are not limited to: performing plan reviews; drafting approval letters; attending site meetings; offering technical assistance via phone; and doing site visits or inspections. The responsible party may be held financially liable for these costs. However, unless circumstances dictate otherwise, the Department will activate the cost recovery process only after LUST Trust Fund costs exceed a threshold of \$1,000.

If this threshold is exceeded, you will be billed the entire amount plus any future costs until the site is closed. The Department will refer this matter to the Office of the Attorney General, who will prepare the actual cost recovery billings.
