Summary of Work Completed On Site -

- 1. Completed all backfill and grading of excavation site on Monday and Tuesday. Also on Monday Lynden Transport moved the PPE container offsite enroute to Chemical Waste Management in Arlington, Oregon.
- 2. On Tuesday afternoon we moved the D5 Dozer to Ammo Storage Area A in preparation to clear a path for the trenching of the cable for the #15 bunker light. The path was marked and cleared on Tuesday. Also on Tuesday we completed loading the Haz Drums in the 40' container and blocked them for shipment.
- 3. On Monday the 17th Earth Resources completed setup and walkthru inspection of their cylinder management systems. On Tuesday they began processing cylinders and completed 14. All were empty.
- 4. On Wednesday the 19th, Earth Resources completed processing the balance of 15 additional cylinders. All were found to be empty.

6. By Friday all office trailers, including Earth Resources, the decon trailer and all other equipment were off site.

The 40' container with Haz Drums was moved from Poleline Road to the Ft. Richardson Hazardous Waste Storage Area in the care of Mario Frisbie until profiles and Canadian Transit notices are completed.
