**STATEMENT OF BASIS**

This decision is based on the results of SERA Phase I Corrective Action Plan (CAP), Final, dated April 1995. Also, reference your 3 May 95 letter, page four, No Further Action Candidate Sites section.

**DESCRIPTION OF THE SELECTED REMEDY**


Based on the current conditions at ST65, it has been determined that no significant risk or threat to public health or the environment exists. Therefore, no further action (NFA) at this site is required.

**DECLARATION**

Site assessment results show no soil contamination above the appropriate soil matrix cleanup level (level B) in Alaska Underground Storage Tank (UST) regulation 18 AAC 78 has been found at ST65. Trace concentrations of diesel range organics (DRO) were found in the groundwater, but are not attributable to this source area. Therefore, this NFA declaration represents the selected action for this site in accordance with SERA. It has been determined that the selected remedy of no further action is protective of human

health and the environment, attains federal and state requirements that are applicable or relevant and appropriate, and is cost-effective. The statutory preference for further treatment is not satisfied because further treatment was not found to be necessary. Contaminant levels at the site have been determined to present no significant threat to human health or the environment; thus, no treatment is necessary.
