Dear Mr. Carlson,

This letter is to advise you that a contaminated site has been identified at the FIA Larry's Flying Service – Block 100 Lot 12A, 3822 University Ave in Fairbanks, Alaska. Since you are identified as a lease holder of this site, you may be financially responsible or liable for the investigation and/or cleanup of any hazardous substance contamination that might be present.

Alaska Statute 46.03.822 (Strict Liability for the Release of Hazardous Substances) establishes who is financially responsible or liable for the investigation and cleanup of any release or threatened release of a hazardous substance. Records available to the Alaska Department of Environmental Conservation (DEC) indicate that you meet one or more of the following criteria:

□ owned or controlled the hazardous substance at the time of its release;

 $\boxtimes$  own(ed) or operate(d) the property or facility from which the release occurred;

 $\Box$  own or operate the property at which the hazardous substance came to be located; or  $\Box$  arranged for transport, disposal or treatment of hazardous substances that were released

## Site History and Background

Alaska Department of Environmental Conservation (DEC) records indicate that contamination at this site was initially found in 2009 during the removal of two 3,000-gallon underground storage tanks used to store aviation fuel. During a subsequent 2019 sampling event performed by Alaska Resources and Environmental Services, all soil samples were below DEC cleanup levels for contaminants of concern. However, groundwater monitoring performed in 2016, 2018, and 2019 has shown at least one exceedance of gasoline and diesel range organics (GRO and DRO), dibromoethane (EDB), and lead at different times, indicating the plume has not stabilized. Additional monitoring is needed to assess groundwater conditions and the remaining groundwater plume.

## Cost Recovery for State Oversight

In accordance with Alaska Statute Title 46, DEC is authorized to provide regulatory oversight for any contamination response efforts initiated by the responsible party. However, if the response actions conducted by the responsible party are not satisfactory to DEC, we may assume the lead role in the investigation and cleanup efforts. In the event that State response actions are necessary, the responsible parties may be held financially liable for any response actions taken by the State.

Alaska Statutes 46.04.010 (Reimbursement for Cleanup Expenses) and 46.08.070 (Reimbursement for Containment and Cleanup) establish cost recovery procedures for certain costs, including oversight activities, incurred by the State in responding to pollution incidents. If you are determined to be a responsible or liable party, DEC may bill you at a later date for our expenditures associated with this site. Those expenses may include the direct cost of staff time plus indirect State overhead costs, and could include travel and contractual costs. Billable staff time includes all time spent on activities related to the incident, including site inspections, response and report reviews, correspondence, telephone conversations, meetings, and legal services. Per Alaska Statute 46.08.075, the State may also file liens against all property owned by a person who is responsible or liable for State expenditures.
