TYPE AND AMOUNT OF PRODUCT SPILLED: Estimated 400 gallons unleaded regular gasoline

CAUSE OF SPILL: Spilt in 2" line between tank farm and dock

TIME AND DATE OF SPILL: Discharge occurred overnight April 23 and April 24, 2001.

POTENTIAL RESPONSIBLE PARTY (PRP): Woodbine Cannery, P.O. Box 218, Egegik, Alaska 99579

CURRENT SITUATION: A split in a two inch steel underground line leading from the Woodbine Cannery's tank farm to the seawall on the Egegik River resulted in the discharge of about 400 gallons of regular unleaded gasoline to the soil between the tank farm and the Egegik River. The gasoline migrated to the bulkhead along the river and 6 foot by 20 foot sheen was observed by cannery personnel in the river about 1115 AM April 24th. The line had been shut in for the winter and was placed back into service on April 23rd in preparation for opening the cannery for the season The line was immediately shut in and drained and sorbent boom, sorbent pads and pillow were placed in the river and on the mud adjacent to the bulkhead. By12:30 PM the entry of product into the river had terminated. No further sheens have been observed during the past two tidal cycles.

Numerous recovery pits were dug between the pipeline and a point about fifteen feet ahead of the bulkhead. As of 9:00 PM April 24th, about 240 gallons of gasoline were recovered. No further flow into the pits occurred overnight.

The soils cleanup is complicated by the site also being a contaminated site from earlier diesel spills. The cannery had planned to resume cleanup of this site May 10th. They are now considering expediting the process and revising the cleanup plan to reduce extent of contamination from this discharge. The damage to the pipeline may have occurred during the soil cleanup last fall. Marks and bends in the pipe in the vicinity of the break indicate that it had been hooked by a back hoe and then set back down into the ground. Cleanup of this site will be closely coordinated with the Department's Contaminated Sites Program.

<u>FUTURE PLANS AND RECOMMENDATIONS:</u> Monitor the cleanup through the cannery personnel. When the situation stabilizes the cleanup will be integrated with the existing cleanup under the contaminated sites program.

WEATHER: Wind were light and variable during the initial response.
