50% Hot Beverage - Available only if type coded as an FN-1, FN-2, FN-3, FN-6

100% 501(c)(3) - Applies to Annual & Plan Review fees (Must submit IRS exempt letter)

50% 501(c)(4), (10), (19) - Applies to Annual fee only (Must submit IRS exempt letter)

20% Assoc Bar/FS - Must be located in same establishment/have same owner/operator

50% After Oct 1st - Only applies to new establishments starting between Oct 1-Dec 30

20% Plan Review - Only applies if an operator submits plans for 3 or more types of operations within a single food establishment.
