Vulnerability Assessment and Emergency Response Plan Biennial Update Certification

Instructions

Public Water Systems (PWS) covered by 18 AAC 80.055 are required to complete a thorough review and update (as appropriate) of their Vulnerability Assessment and Emergency Response Plan (VA and ERP) every two years. The PWS Owner must submit this form to certify that the VA and ERP has been updated.

1. Use this form **ONLY** for the following Public Water Systems (PWS):

- Community Water Systems (CWS) serving 1,000 persons or more;
- Non-Transient Non-Community Water Systems (NTNC) serving 1,000 persons or more.

CWS and NTNC less than 1,000 persons and Transient Water Systems (TNC) DO NOT USE THIS FORM. Use the Priority Measures Plan Biennial Update Certification Form.

2. Complete this form (pages 1-2) and submit it to the DEC.

3. Keep a copy of this form with your Emergency Response Plan.
