POTENTIAL RESPONSIBLE PARTY (PRP): Colville Transport, LLC

INCIDENT LOCATION: Mile 382.5 Dalton Hwy, 31 miles south of Deadhorse, AK

TIME/DATE OF SPILL: 01:00 AM on August 24, 2018

HOW/WHEN SPILL WAS DISCOVERED AND REPORTED: The truck rollover was reported to DEC via phone call at approximately 04:30 AM on August 24, 2018.

TYPE/AMOUNT OF PRODUCT SPILLED: An unknown volume of diesel was released as a result of the truck rollover. The tanker truck has the capacity to carry 10,000 gallons of refined fuel product.

CAUSE OF SPILL: A tanker truck owned by Colville Transport LLC left the road and rolled over. Causal factors in the truck rollover are not known at this time.

SOURCE CONTROL: All diesel being transported by the truck has been lightered.

RESPONSE ACTION: A vac truck has been dispatched to recover free product in the environment. A DEC responder is on route to the rollover site. DEC is working with DNR, DOT and Colville Transportation on the response. Colville Inc. has also issued a press release associated with this event.

RESOURCES AT RISK OR AFFECTED: The area of the rollover is on tundra. Wildlife including caribou, fox, and migratory birds are frequently observed in the area.

FUTURE PLANS AND RECOMMENDATIONS: Crews will continue to remove product from the tanker and recover free product from the environment.

WEATHER: 36 F, East wind 15 mph, heavy fog/mist, visibility under 1 mile
