Dried Egg Products Recalled for Possible Salmonella Contamination

(JUNEAU, AK) – Nutrium LLC has issued a recall for processed egg products for possible contamination with Salmonella. Consumption of food contaminated with salmonella can cause salmonellosis, one of the most common bacterial foodborne illnesses. The most common symptoms of salmonellosis are diarrhea, abdominal cramps and fever within 12 to 72 hours after eating the contaminated product. The illness usually lasts four to seven days. Most people recover without treatment. In some persons, however, the diarrhea may be so severe that the patient needs to be hospitalized. Older adults, infants and persons with weakened immune systems are more likely to develop a severe illness. Individuals concerned about an illness should contact their health care provider.

The dried egg products were produced between Feb. 28, 2013 and Feb. 8, 2014, and may be identified by the establishment number “INSPECTED EGG PRODUCTS PLANT 21493G” inside the mark of inspection.
