**Buona Vita Frozen, Ready-To-Eat Meat and Poultry Products  
Recalled for Listeria Monocytogenes Contamination**

(JUNEAU, AK) – Buona Vita, Inc. has issued a recall for multiple frozen, ready-to-eat meat and poultry products due to possible contamination with *Listeria monocytogenes*.

*Listeria monocytogenes* can cause listeriosis, a potentially fatal disease. Healthy people rarely contract listeriosis. However, those that do contract it could experience high fever, severe headache, neck stiffness and nausea. Listeriosis can also cause miscarriages and stillbirths, as well as serious and sometimes fatal infections in those with weakened immune systems, such as infants, the elderly and persons with HIV infection or undergoing chemotherapy. People experiencing these symptoms should seek immediate medical attention.

The recalled items were produced on June 26, 2012 under several brand names:

The recalled packages bear the establishment number "P-954" or "Est. 954" inside the USDA mark of inspection and can also be identified by case code 1782.
