Standard [OPERATING] Permit Condition X – Reasonable Precautions to Prevent Fugitive Dust

<u>Emissions</u> [EMISSION] **Units or Stationary Sources This Condition Applies to:** A stationary source containing any of the following:

- a. coal-fired boilers;
- b. coal-handling equipment;
- c. construction of gravel pads or roads that are part of a permitted stationary source, or other construction that has the potential to generate fugitive dust that reaches ambient air;
- d. commercial, industrial, municipal solid waste, air curtain, and medical waste incinerators;
- e. sewage sludge incinerators not using wet methods to handle the ash;
- f. mines;
- g. urea manufacturing;
- h. soil remediation units;
- i. dirt or gravel roads under the control of the operator with frequent vehicle traffic;
- j. other <u>emissions</u> [EMISSION] units the <u>Department</u> [DEPARTMENT] finds are likely to generate fugitive dust.

The <u>Department</u> [DEPARTMENT] will use Standard Permit Condition (<u>SPC</u>) X in an operating permit for any of the <u>emissions</u> [EMISSION] units listed in a – j above, unless the <u>Department</u> [DEPARTMENT] determines that <u>emissions</u> [EMISSION] unit<u></u> or stationary source<u>-</u>specific conditions more adequately meet the requirements of 18 AAC 50 or the <u>Department</u> [DEPARTMENT] determines that the stationary source has no potential to cause fugitive dust problems.

Circumstances where <u>emissions</u> [EMISSION] unit_ or stationary source_specific conditions more adequately meet 18 AAC 50 include:

- 1 problems persist after a complaint; or
- 2 the need for a dust control plan or other specific requirements is foreseeable due to stationary source-specific circumstances.

Permit Wording:

1. A person who causes or permits bulk materials to be handled, transported, or stored, or who engages in an industrial activity or construction project shall take reasonable precautions to prevent particulate matter from being emitted into the ambient air.

- 1.1 The **Permittee** [PERMITTEE] shall keep records of:
 - a. complaints received by the <u>Permittee</u> [PERMITTEE] and complaints received by the **Department** [DEPARTMENT] and conveyed to the **Permittee** [PERMITTEE]; and
 - b. any additional precautions that are taken

- (i) to address complaints described in <u>Condition</u> [CONDITION X.]1.1a or to address the results of <u>Department</u> [DEPARTMENT] inspections that found potential problems; and
- (ii) to prevent future dust problems.
- 1.2 The <u>Permittee</u> [PERMITTEE] shall report according to <u>Conditions</u> [CONDITION] < insert cross <u>references</u> [REFERENCE] to <u>SPC</u> [STANDARD PERMIT CONDITION] II <u>Air</u> <u>Pollution Prohibited</u> [AIR POLLUTION PROHIBITED] reporting condition numbers>.
