DEC proposes to re-issue APDES general permit AKG528000 to onshore seafood processing facilities located in Kodiak, Alaska that discharge seafood processing waste and wastewater to waters of the U.S. The permit authorizes discharges to several receiving waters, including Kodiak Harbor, St. Paul Harbor, Gibson Cove, Near Island Channel, Women's Bay, and Woody Island Channel.
