## Notice of Public Comment Period for Proposed Updates to the Pribilof Islands Wildlife Protection Guidelines for Oil Spill Response, Version 2023.1 (January 2023)

The Alaska Department of Environmental Conservation (DEC) and the Alaska Regional Response Team (ARRT), Pribilof Islands Working Group, are seeking public input for proposed updates to the *Pribilof Islands Wildlife Protection Guidelines for Oil Spill Response, Version 2023.1 (January 2023).* The purpose of this document is to provide guidance for responders and planners when addressing wildlife concerns during an oil spill response in the vicinity of the Pribilof Islands. This guidance document is incorporated by reference into the *Arctic and Western Alaska Area Contingency Plan* and is considered a companion document to the *Wildlife Protection Guidelines for Oil Spill Response in Alaska*. The public comment period for this document begins on January 9, 2023 and ends at 11:59 p.m. (Alaska Standard Time) on February 7, 2023.

Commenters opting to submit comments electronically (either via the DEC public comment webpage or email) are encouraged to use a spreadsheet to organize their comments.

Accordingly, a "Comment Response Matrix" spreadsheet in Microsoft Excel format is available for download on the DEC response planning public review webpage. This matrix was developed to streamline the public comment process and provide an efficient means for agency reviewers to process feedback. The completed matrix may be submitted via either uploading the file to the DEC public comment webpage or attachment to an email. While use of the Comment Response Matrix is the preferred method for organizing comments, it is not a requirement. Comments may also be submitted in narrative form via the DEC public comment webpage, email (either in the text body or a file attachment), or a hardcopy letter. All hardcopy letters must be postmarked on or prior to the last day of the public comment period, or if handdelivered, received by DEC at the office listed above by the close of business (4:30 p.m. Alaska Standard Time) on the last day of the public comment period.

The contents of all submitted comments are considered public records and will be posted online in full, regardless of submission method used.

After the public comment period ends, DEC, and the ARRT Pribilof Islands Working Group will carefully evaluate and consider all proposed updates to the document. They will aggregate responses to similar questions and make the questions and responses available to the public on the DEC response planning public review webpage. If needed, commenters will be contacted by working group members to clarify any questions or comments, unless contact information was not provided. After all feedback and proposed changes have been evaluated, the ARRT Pribilof Islands Working Group will either adopt the proposed changes without further notice, revise the proposed changes with information from public review and adopt without further notice, or decide to take no action.
