# State of Alaska Import Requirements March 2017

## **POULTRY\*/HATCHING EGGS/LIVE BIRDS**

\*Poultry is defined as chickens, turkeys, ratities (flightless birds), waterfowl, game birds, pigeons, doves, and other domestic fowl.

## **General Importation Requirements**

- 1. All poultry, hatching eggs, and live birds imported into Alaska must be accompanied by an <u>Alaskan importation permit</u> and <u>health certificate or APHIS VS form.</u>
  - Both documents must be attached to the waybill for the animal and must accompany the animal at all times.
  - **Exception:** Animals intended for <u>immediate slaughter</u> (within 10 days of arrival) do not require a health certificate if the appropriate conditions are met (see note below for further information).
- 2. No animal may be imported that is affected with an infectious, contagious, or communicable disease, or is known to have been exposed to one in the last 30 days.
- 3. No animal may be imported that originates from a quarantine area as designated by another state, federal government, or foreign country.
- 4. Animals must be transported in a vehicle appropriate for the size and number of animals being transported, free of hazards that could injure the animals, and maintained in a sanitary condition.

#### Importation Permit Requirements

- 4. Importation permit applications can be completed online by a veterinarian at: <u>http://dec.alaska.gov/Applications/EH/ATS/index.html</u>
- 5. Permit is valid for 30 days after issuance and is non-transferable.
- 6. A single permit may be obtained for multiple animals of the same class.
- 7. Application must include:
  - (1) Name, address, and contact information of the person who is importing the animal, and for the person who will be responsible for the animal in Alaska;
  - (2) Physical address or point of origin of the shipment;
  - (3) Physical address of the destination of the shipment; and
  - (4) Results of required diagnostic tests.
- 8. Alaskan importation permit must be affixed to health certificate and identified on any other official document as "Alaska Permit No. \_\_\_\_."

Health Certificate/Certificate of Veterinary Inspection Requirements

- Health certificates can be obtained from any licensed and accredited veterinarian in the state or country of origin; one copy of the certificate must be provided to the Alaska State Veterinarian.
- 2. Valid for 30 days after issuance.
- 3. Certification must include:
  - (1) Name, address, and contact information of the person who is importing the animal, and for the person who will be responsible for the animal in Alaska;
  - (2) Physical address or point of origin of the shipment;
  - (3) Physical address of the destination of the shipment;
  - (4) Age, sex, breed, color, and markings of each animal;
  - (5) Official identification for each animal;
  - (6) Dates and records of required tests or vaccinations;
  - (7) Certification that each animal:
    - i. Is free from evidence of, or known recent exposure to, infectious, contagious, or communicable diseases;
    - ii. Originates from a flock that has tested negative for pullorum and typhoid disease within 30 days of import, **OR** were produced in compliance with:
      - 9 C.F.R 145.1-145.54 (National Poultry Improvement Plan for Breeding Poultry);

- 2. 9 C.F.R. 147.1-147.48 (Auxiliary Provisions of National Poultry Improvement Plan); and
- 3. The National Poultry Improvement Plan Standards.
- (8) Date and place of examination; and
- (9) Name, contact information, and signature of the certifying veterinarian.
- A complete APHIS VS Form 9-3, Report of Sales of Hatching Eggs, Chicks, and Poults may be substituted for the health certificate or certificate of veterinary inspection.

Animals intended for **immediate slaughter** do not require a health certificate if:

- 1. An import permit accompanies the shipment;
- 2. The waybill that accompanies the shipment states the animal is for immediate slaughter;
- 3. The animal is kept in an official USDA-approved, federally-inspected slaughterhouse; and
- 4. The animal will be slaughtered within 10 days, or an exception is granted by the State Veterinarian.

If the above conditions are not met, or it is determined to serve the interests of animal or public health, the State Veterinarian may order an animal guarantined at the owner's expense until such time as it is released from guarantine, euthanized, slaughtered, or destroyed.

## **Requirements for Importation of Animals Originating in Canada**

- 1. All State of Alaska import requirements must be met, as described above.
- A USDA Entry Permit issued by the National Center for Import/Export (NCIE) must be obtained: <u>https://www.aphis.usda.gov/aphis/ourfocus/importexport</u>, <u>VS-</u> <u>Live.Animals Import.Permits@aphis.usda.gov</u>, or (301) 851-3300.

3. Animals must be kept isolated at the destination until they are checked post-entry by the Alaska USDA APHIS Veterinary Medical Officer (VMO). It is the responsibility of the owner to contact the USDA to arrange for an inspection.

#### **Requirements for Exportation of Animals to Canada**

- 1. Due to the prevalence of Highly Pathogenic Notifiable Avian Influenza (HPNAI), all animals must be imported from a country, zone, or compartment free from HPNAI, and submit to official veterinary inspections, quarantine periods, or testing, as required.
- 2. Imported birds must not have been vaccinated against AI.
