Proposed Project and Location:

The Municipality of Anchorage Municipal Separate Storm Sewer System permit addresses storm water discharges within the Municipality. There are multiple outfalls into many receiving waters. The permit addresses construction activities, post construction activities, monitoring for illicit discharges, snow disposal practices, street sweeping requirements and practicing pollution prevention techniques. No mixing zone is proposed.

Tentative Determination:

DEC has tentatively determined to reissue an individual permit to the above listed activity.
