Subject: Alaska Registration and Reporting for Large Commercial Passenger Vessels¹

Dear Cruise Ship Operator:

Thank you for choosing Alaska as your destination. To assist you in complying with our state laws and regulations² we have combined several legal requirements into a single process, described below:

- 1. Vessel Registration (AS 46.03.461 and 18 AAC 69.010),
- 2. Environmental and Ocean Ranger Fees (AS 46.03.480, 46.03.476 and 46.03.480(d)),
- 3. Wastewater Discharge and Required Plans (AS 46.03.462, AS 46.03.465, 18 AAC 69.015, 18 AAC 69.025-040, and 18 AAC 69.065),
- 4. Vessel Position Reporting (AS 46.03.465(b))

Registration

The Alaska Department of Environmental Conservation (ADEC) requires that vessels register online by March 1, 2021. Operators must register each commercial passenger vessel that they intend to operate in Alaska marine waters in 2021.

The only registration document that you must mail to us is the original notarized vessel owner or operator's signature page. The online registration application generates the signature page document at the end of the process.

Due to the current uncertainties surrounding the 2021 season, if any registration changes need to be made after March 1, please contact the Commercial Passenger Vessel Environmental Compliance (CPVEC) Program. The CPVEC Program will assist you with changes on a case-by-case basis.

Registration will ask if you plan to discharge wastewater into the marine waters of the state³. You may change the registered discharge status at any time before the season begins by contacting the CPVEC Program. Discharging vessels will need to either 1) submit a sampling Quality Assurance Project Plan

¹ Large commercial passenger vessels provide overnight accommodations for 250 or more passengers, determined by the number of lower berths (see Alaska Statute, AS 46.03.490 (7)).

² Alaska Statute (AS) are laws and Alaska Administrative Code (AAC) are state regulations.

³ Marine waters of the state are generally defined as three nautical miles from coast and all waters of the Alexander Archipelago (Inside Passage). For specific latitude and longitudes, see AS 46.03.490 (18).

(QAPP) or 2) inform us that you will use the most recently ADEC approved Cruise Line International Association QAPP.

All vessels, regardless of discharge intent, are required to submit solid waste and hazardous waste disposal plans. These plans can be uploaded during registration or sent separately.

Environmental and Ocean Ranger Fees

On or before June 1, 2021 operators of commercial passenger vessels must pay a CPVEC fee and an Ocean Ranger fee. The CPVEC Fee is based on passenger capacity (lower berths) and the number of voyages. The Ocean Ranger fee is a separate \$4 per berth, per voyage fee. The online registration process will tell you what your fee charges are. Invoices will be sent to the billing address listed in the vessel registration.

Wastewater Discharge and Required Plans

Any vessel intending to discharge must request coverage under the 2014 Large Commercial Passenger Vessel Wastewater Discharge General Permit. Required sampling and reporting requirements are outlined in the General Permit. Please refer to the attached Description of Required Plans for information regarding the required plans. General Permit Extension

ADEC is in the process of extending the 2014 General Permit (2013DB0004) to cover the 2021 cruise ship season. Additional information will be sent out once that process is completed.

Vessels intending to discharge in Alaska waters in 2021 must either 1) have a 2019 or 2020 Notice of Intent (NOI) on file with ADEC or 2) submit a new NOI. The NOI acts as the application under 18 AAC 15.110 for permit coverage during the GP extension period. Please update and check that the Notice of Intent on file with ADEC accurately reflects current treatment equipment and operations.

If your vessel is intending to discharge in Alaska waters in 2021 and your vessel does not have a 2019 or 2020 Notice of Intent (NOI) on file with ADEC, please contact the CPVEC Program.

Vessel Position Reporting

Vessel operators must provide hourly positional information to ADEC (AS 46.03.465(b)). ADEC cannot recommend a contractor to provide this service. In 2018, all operators contracted with the Marine Exchange of Alaska (907-463-2607). Other sources of vessel tracking must be approved by ADEC.

Other Requirements

The ADEC Spill Prevention and Response (SPAR) Division and the Air Quality Program are in different divisions than the Cruise Ship Program and have their own separate requirements. Links to this information are on the attached "Useful Websites" page.

In addition to ADEC's large cruise ship requirements, federal agencies (EPA and U.S. Coast Guard) have requirements for discharging wastewater in Alaska waters. It is the responsibility of vessel owners or operators to register with the appropriate federal agencies. U.S. Coast Guard Sector Juneau can be
