POTENTIAL RESPONSIBLE PARTY (PRP): Carlile Transportation Systems LLC

INCIDENT LOCATION: MP 142 Sterling Highway, 59.960260, -151.729828

DATE/TIME OF SPILL: July 27, 2021, at 8:00 a.m.

HOW/WHEN SPILL WAS DISCOVERED AND REPORTED: The Alaska State Troopers reported that this spill occurred when a tanker truck carrying 12,500 gallons of crude oil in two tanker trailers rolled over during a traffic accident on the Sterling Highway. One of the tankers was damaged, causing release of product.

TYPE/AMOUNT OF PRODUCT SPILLED: The spilled product is Crude Oil. The tanker truck was transporting 12,500 gallons of Crude Oil. The amount of spilled Crude Oil is currently estimated to be 900 gallons.

CAUSE OF SPILL: A head on collision between the tanker truck and another vehicle.

SOURCE CONTROL: The source is controlled at this time. Remaining product has been removed from the damaged tank.

RESPONSE ACTION: The tanker truck is no longer leaking at this time. Boom has been placed to prevent further migration of product. The response action contractor U.S. Ecology is on scene and has begun removing product from the tanker. ADEC responders are on scene and providing oversight.

RESOURCES AT RISK OR AFFECTED: There are nearby wetlands, which support a number of birds (e.g. waterfowl, shorebirds, gulls and eagles) which may be present near the spill area. It is expected that there are moose and other fur-bearing mammals in the area. There have been no reports of impacts to wildlife. The Sterling Highway remains open, traffic control measures are being planned. It is likely that contamination extends beyond the Alaska Department of Transportation right of way, but at this time the area is heavily vegetated and the extent of contamination will be investigated.

FUTURE PLANS AND RECOMMENDATIONS: Following removal of the product the tanker truck and trailers will be righted and removed. The area affected by the spill will be delineated, and affected soils will be removed for remediation.

WEATHER: Currently, 60°F. Wind 11 mph, partly cloudy, 2% chance of rain.
