

# AK Cruise Ship Registration

## Voyage Number – Notice of Change

Alaska Department of Environmental Conservation  
Commercial Passenger Vessel Compliance Program (CPVEC)

### Purpose:

The DEC OASys (Online Application System) does not allow edits once the **Signature Page** is printed off. Use this form to adjust the number of voyages for the AK Season, when:

- ✓ Registration is locked preventing edits, and
- ✓ DEC has NOT received payment for fees.

**NOTE: This form is only for voyage# changes.**  
**Changes to any information required under AS 46.03.461, requires a new notarized Signature Page.**

### Voyage Change Instructions:

Step 1. In OASys, Copy information to new Registration #:

- Log into myAlaska (<https://dec.alaska.gov/water/oasys/>) and Open the Tracking # you want to modify.  
**NOTE: Tracking # (in OASys) = 2022 Cruise Ship (CS) Registration # (e.g., 2022CS0001, 2022CS0052, etc.)**
- Click on the "Copy to New" button at the bottom of the page.
- Then click 'Create New Submittal'

**Note:** "Copy to New" creates a new registration (e.g. new #) using information from the original registration.

Step 2. Edit Voyages:

- Edit the "Number of Voyages" field in STEP 1
- Click 'Save & Continue'

Step 3. Complete New Registration

- Click 'Save & Continue' for STEP 2 through STEP 5.
- **NOTE: STEP 3 will require you re-answer questions related to DISCHARGE STATUS**
- **The new registration will remain incomplete until you answer and click 'Save and Continue'**
- STEP 6 (Note: you can print registration for your records). Click 'Home'
- The new registration should say 'Completed and Not Signed, Not Paid' in the Status section.
- You **DO NOT** have to print out / sign the new registration signature page. Your original Signature Page is still valid.

Step 4. Fill in this form:

- Fill in the required information in the Table below.
- Sign and Date this form and send to DEC Cruiseship Program ([DEC.WQ.Cruise@alaska.gov](mailto:DEC.WQ.Cruise@alaska.gov))  
(Notarization is NOT required)
