Subject: SIP Submittal of Repealed Ice Fog and SO<sub>2</sub> Special Protection Areas SIP Revisions

Dear Mr. Sixkiller:

This letter provides amendments to Alaska's *State Air Quality Control Plan* or State Implementation Plan (SIP) to repeal the Ice Fog and SO<sub>2</sub> Special Protection Areas regulations and associated cross-referenced regulations, update adoption by reference dates for federal regulations in 18 AAC 50.040 and repeal the Ice Fog section of the SIP. The revised regulations have an effective date of April 16, 2022. Specific provisions are submitted for EPA approval, while other provisions are included for informational purposes only, to show a complete record of the rulemaking.

On March 17, 2022, the Lt. Governor signed and filed the following changes to the Alaska Department of Environmental Conservation's (DEC) regulations in 18 AAC 50:

- Repeal 18 AAC 50.025(c) to repeal special protection areas for sulfur dioxide (SO2).
- Amend 18 AAC 50.030(a) to adopt revisions to the State Air Quality Control Plan by
  - o repealing Volume II, Section III.E Ice Fog; and
  - o amending Volume III Appendix to Volume II, Section II.A to incorporate the proposed regulations after public review and comment. This appendix within the State Air Quality Control Plan contains the state's air quality regulations.
- Amend 18 AAC 50.035(b) to update the adoption by reference of federal regulations.
- Amend 18 AAC 50.040(a) − (c) and (h) − (j) to update the adoption by reference of federal regulations.
- Repeal 18 AAC 50.080 to repeal the ice fog regulations.
- Amend 18 AAC 50.502(c)(2)(B), .540(c)(2)(B), .540(c)(2)(C), and .542(a)(1)(B) to repeal cross references to the 18 AAC 50.025(c) repealed language.

DEC is submitting the relevant parts of the Repeal of Ice Fog and SO<sub>2</sub> Special Protection Areas amendments for to EPA for approval today. Changes to the following revised sections of the *State Air Quality Control Plan*/SIP and 18 AAC 50 are being submitted for approval:

- Repeal of SIP Volume II, Section III.E Ice Fog
- 18 AAC 50.025(c)
- 18 AAC 50.035(b), except (b)(4)
- 18 AAC 50.040(h) and (i)
- 18 AAC 50.080
- 18 AAC 50. 502(c)(2)(B)
- 18 AAC 50. 540(c)(2)(B) and .540(c)(2)(C)
- 18 AAC 50.542(a)(1)(B).

We will submit the documents listed in the enclosures via the EPA's SPeCS system. If requested, we can provide one paper copy and one electronic version of the documents to Kristin Hall of your staff (note that the electronic version would be an exact duplicate of the paper copy).
