Good afternoon-

At this time, the state does not have the regulatory framework to permit the leasing of its lands for CCS projects. Although, this is something DNR is currently exploring legislation for, in concert with representatives of ADEC, AOGCC, and ADOR. Accordingly, any developments of CCS as it relates to AK LNG are high level discussions about the potential role CCS could play in their marketing strategy and their enthusiasm to see the state explore the regulatory framework that would make it possible.

In addition to the regulatory framework, there is still a great deal of work yet to do to further delineate the storage potential of the state, particularly in Cook Inlet. Our Division and DGGs are keen to participate in these studies and will have more work related to this forthcoming.
