## **State Revolving Fund Eligibility**

## **Eligible Borrowers**



Entities that are eligible to borrow from the State Revolving Fund (SRF) Program include municipally owned public drinking water and wastewater systems, as well as non-profit and private water systems that are economically regulated by the Regulatory Commission of Alaska. Some privately owned wastewater systems are also eligible.

## **Eligible Projects**

### **Clean Water SRF**

- **Construction of publicly owned treatment works:** Projects that include primary and secondary treatment, advanced treatment, sewer system repair and replacement, combined sewer overflow correction, resiliency, and security.
- Nonpoint source projects: Projects that implement a state's nonpoint source management plan, such as agricultural best management practices, streambank restoration, etc.
- Decentralized wastewater treatment systems: Repair, replacement, or upgrade of decentralized wastewater treatment systems such as community septic tanks and lagoons.
- **Stormwater:** Gray and green infrastructure to address water quality impacts of stormwater runoff.
- Water conservation and efficiency: Projects that reduce the demand for publicly owned treatment works' capacity through reduced water consumption.
- Watershed pilot projects: Development and implementation of watershed projects meeting the criteria in Clean Water Act (CWA) section 122.
- Energy efficiency: Projects that reduce the energy consumption needs for publicly owned treatment works.
- Water reuse: Projects for reusing or recycling wastewater, stormwater, or subsurface drainage water.
- Security measures at publicly owned treatment works: Projects to increase the security of publicly owned treatment works.
- Technical assistance: Projects implemented by a nonprofit entity to provide technical assistance to owners and operators of small and medium sized publicly owned treatment works to plan, develop, and obtain financing for Clean Water SRF eligible projects and to assist each treatment works in achieving compliance with the CWA.

#### **Drinking Water SRF**

- **Treatment:** Projects to install or upgrade facilities to improve drinking water quality to comply with drinking water regulations.
- Transmission and distribution: Rehabilitation, replacement, or installation of pipes to improve water pressure to safe levels or to prevent contamination caused by leaky or broken pipes, including lead service line replacement.
- **Source:** Rehabilitation of wells or development of eligible sources to replace contaminated sources.
- **Storage:** Installation or upgrade of finished water storage tanks to prevent microbiological contamination from entering the distribution system.
- **Consolidation:** Interconnecting two or more water systems.
- Creation of new systems: Construct a new system to serve homes with contaminated individual wells or consolidate existing systems into a new regional water system.
